6. KPD Offers Bicycle Safety Fair

The Knoxville Police Department will conduct its annual Bicycle Safety Fair on this Saturday, Sept. 21, from 10:00 a.m. to 2:00 p.m., with the last group starting at 1:30 p.m.

The free fair takes place at Safety City located at 165 S. Concord Street, Knoxville, TN 37919 (between Kingston Pike and Sutherland Avenue).

7. KCDC to Hold Workshop on Five Points Master Plan

Knoxville's public housing and redevelopment agency, KCDC, will hold a workshop from 5:30 to 7:30 p.m. Wednesday, September 25, to gather public input for the next phases of the Five Points Master Plan. The event will take place in the gymnasium of the Boys and Girls Club at Walter P. Taylor Homes, 317 McConnell Street.

The Five Points Master Plan team, led by Johnson Architecture, and including Atlanta-based urban design firm Urban Collage and financial planning company TCG International, will create a detailed action plan on the future housing and infrastructure built in the neighborhood, as well as specific avenues of funding.

The planning team has conducted surveys and compiled market research about Five Points that will be presented at the meeting.

"We have conducted a detailed study of the neighborhood and its resources in preparation to begin the planning process, but we will never know as much about this community as the residents who live here," said Johnson Architecture Partner Kristin Grove. "These public meetings are crucial for us to understand the existing fabric of the community and its hopes for the future."

Five Points projects already completed include:

** In 2011, KCDC opened the Residences at Eastport, an 85-unit, LEED-Platinum-certified senior housing development in Five Points.

** Senior housing duplexes were added in 2010, placing an additional twenty housing units to the community. These developments are fully leased.

** Infill housing is also underway. Two duplexes and a single family home have already been constructed and leased, and two six-plex residences will open this winter.

Beginning in August of 2012, 86 units of Walter P. Taylor Homes and 97 units of Dr. Lee L. Williams Senior Complex were demolished as part of a first phase to replace older public housing in Five Points with new units. By this winter, 122 units will have been constructed to replace the demolished units. Residents displaced by the demolition of Walter P. Taylor Homes have received priority placement in a new unit in Five Points, priority placement at another KCDC property or a Section 8 voucher.

The Five Points Master Plan development process will include three public workshops and is expected to conclude in 2014.

8. Heads Up: MPC Provides First Look at October Agenda

Land use changes can have positive or negative impacts on a neighborhood, so it is critical that neighborhood leaders keep up with proposed developments in or near their communities.

The Metropolitan Planning Commission meets at 1:30 p.m. on the second Thursday of each month to consider rezonings, uses on review, approval of development plans, and development plan amendments. Some of these items proceed to City Council automatically, and some only if there is an appeal.

Details on each item are contained within the agenda that is made available on the Friday before the monthly meeting. MPC provides advance notices of agenda items. The first notice is made available on the MPC web site at least three weeks before each meeting. Once the preliminary agenda is posted, this announcement will be removed because the preliminary agenda (the second advance notice, posted two weeks prior to the meeting) will contain more up-to-date information. Note that the MPC agenda page also advises that changes and additions can be posted as late as Tuesday before the monthly meeting.

9. Community Development Seeks Action on Blighted Properties

The city's Better Building Board next week will consider action on two properties that ultimately could be acquired by the city at fair market value using its eminent domain powers, if the owners fail to address codes violations.

Neighborhood groups may wish to be present to testify on the impact of these properties on the neighborhood. The BBB meets at 3:30 p.m. Thursday, September 26, in the small assembly room of the City County Building.

The properties include a blighted structure at 434 East Quincy Avenue and a vacant lot on Candler Avenue.

The BBB --- composed of five citizens appointed by the Mayor --- will be asked by the Community Development Department to either "determine" or "certify" that the properties are blighted based on criteria spelled out in a city ordinance. These are the first steps toward the city possibly acquiring the properties at fair market value, if the owner fails to take steps to cure the blight.

10. Neighborhoods Can Testify on Blighted Properties

Twenty two residential properties and one commercial property are on the agenda for the City's next Public Officer Hearing at 9:30 a.m. Friday, September 27.

The Public Officer --- David Brace, director of the Public Service Department --- will hear testimony on buildings that inspectors contend are in violation of the city's building codes. Testimony can also be made by the property owners, neighbors, neighborhood groups, and other stakeholders, such as lien holders.

The Public Officer then decides whether to issue an order requiring that the violations be addressed in a certain period of time. Failure by the owner to cure the problem may result in the boarding or demolition of a structure, or the cleanup of a dirty or overgrown lot, with costs billed to the owner. A property owner may appeal the Public Officer's decision to the Better Building Board and ultimately to Chancery Court.

The properties that have been approved to be heard for repair/demolition orders are : 251 East Anderson Avenue, 842 Avenue A, 205 Catlett Road including accessory structure, 923 North Central Street, 931 North Central Street, 937 North Central Street, 2226 Cityview Avenue, 5918 Clinton Highway (Lot #38), 238 West Ford Valley Road (a/k/a 240 West Ford Valley Road), 6919 Haverhill Drive (pool only), 200 Hiawassee Avenue including accessory structure, 3505 Martin Luther King Jr. Avenue, 1711 Maryland Avenue, 510 Midlake Drive including accessory structure, 2109 Mississippi Avenue, and 823 West Oak Hill Avenue including accessory structures.

The properties that have been given emergency repair/demolition orders and are now to be confirmed are: 122 South Central Street, 4208 McCalla Avenue including accessory structure, 515 Scenic Drive, and 211 East Springdale Avenue (accessory structure only).

Properties listed for boarding approval are: 205 Catlett Road, 210 South Elmwood Street, 238 West Ford Valley Road (a/k/a 240 West Ford Valley Road), 109 James Agee Street, 3505 Martin Luther King Jr. Avenue, 510 Midlake Drive, 2109 Mississippi Avenue, and 823 West Oak Hill Avenue.

If any of these properties are in your neighborhood, you might wish to consider sending a representative of your organization to the meeting to submit testimony about the impact of the property on the neighborhood.
