1. Ribbon Cutting Opens South Knox Outdoor Classroom

Partners in the concept, design and construction of an outdoor classroom in South Knoxville cut the ribbon on the new facility this morning.

The South Doyle Middle School Outdoor Classroom --- a scenic area overlooking Baker Creek on the edge of the South Doyle campus --- includes a 90-seat amphitheater set into the hillside and a "labitat" (combination lab and habitat) stream ecology research area along a 50-foot section of the creek.

The project began as a collaboration between South Woodlawn Neighborhood Association (SWNA) and South Doyle Middle School. It became a reality when the project won the annual \$30,000 Dow Gives Community Grant. Additional support came from a variety of sources, including TVA, The Water Quality Forum, Knox County School Board Member Pam Trainor, City Council Member and Vice Mayor Nick Pavlis, Knox County Commissioner Mike Brown, and Legacy Parks Foundation..

The outdoor classroom will be used by all grades at the school and will also be available for community events. The project aided South Woodlawn Neighborhood Association's successful bid for the neighborhood to become Tennessee's first Certified Community Wildlife Habitat.

Further enhancements are planned. For example, the neighborhood group and the school are working with a construction class at South Doyle High School to build steps to and a walkway along the creek to help students studying the ecology of the creek.

SWNA this week recognized the businesses who donated or deeply discounted services and materials, without which the project cost would have greatly exceeded the \$32,270 that was raised. They are Perfect Ideas LLC (the general contractor); Mark V Graham Engineering Consultants, LLC; Lane Excavating; Jarrett Benson Design; Ayala, LLC Masonry Contractor; Acme Block & Brick; and Aggregates USA.

2. Suzanne Kurth, Neighborhood Leader

Longtime neighborhood leader Suzanne Kurth passed away November 18 after a battle with cancer.

Suzanne was a tireless neighborhood advocate, serving as president of her own Lonas Drive Community Association for many years and participating in countless city-wide meetings about neighborhood-related issues and concerns.

For seven years she served on the Mayor's Neighborhood Advisory Council and its precursor --- the task force that recommended to then Mayor Bill Haslam that the city establish an Office of Neighborhoods. She volunteered for the committee that helped plan the city's first neighborhood conference last March.

After earning her Ph.D. in sociology from the University of Illinois at Chicago in 1971, Suzanne taught in the Sociology Department at the University of Tennessee for over 40 years, chairing the department for part of that time, and mentoring many graduate and undergraduate students. Her areas of interest were social psychology, gender, and family.

The first chair of the university's Women's Studies Program, she was a calm but disciplined diplomat who broke new ground in many ways, especially for women in academia.

Suzanne was a thoughtful and engaged citizen of Knoxville. She will be missed.

3. Old North Schedules 25th Annual Home Tour

Historic Old North Knoxville (ONK) will host its 25th Annual Victorian Holiday Tour of Homes on Saturday and Sunday, December 7 and 8.

The family event showcases 11 Victorian and Craftsman style homes and one historic church, all festively decorated for the holidays. Visitors on this year's tour will see a special new edition, a restored home featured on DIY Network's show "Uncondemned".

While last year's tour set an attendance record with nearly 1700 visitors, this year's event is expected to break another record as tour participants are joined by viewers of the DIY Network show, who followed the evolution of 1417 Cornelia Street from a burn-out to a fully restored and energy efficient home.

The December 7 candlelight tour occurs from 4:00-9:00 p.m., and the December 8 afternoon tour lasts from 12:30 p.m.-5:00 p.m. Guests should allow two to three hours to enjoy the event. Parking and continuous trolley service is available off Woodland Avenue at the Tennova/St. Mary's Hospital parking lot. Holiday ornaments will be on sale at tour stops.

Advance tickets are on sale until midnight Friday, Dec. 6, for \$10 at area Kroger stores and via Paypal at www.OldNorthKnoxville.com. Day-of-event tickets are \$15; senior tickets are \$10, and children under 12 get in free with an adult.

Be advised: Some walking is necessary, and some houses have steps. Trolleys will transport visitors from house to house and also stop in the Happy Holler business district on Central Avenue, providing the opportunity to enjoy drinks or food at local restaurants.

6. Mural Project Earns an Orchid

Keep Knoxville Beautiful recently held its 32nd annual Orchids Awards celebration, and one of the winners was the Sixth Avenue Mural Project --- the effort spearheaded by residents of the Parkridge neighborhood to transform the Sixth Avenue underpass.

The underpass (I-40 passes overhead) includes not only Sixth Avenue and the most direct connection from Parkridge to the Old North Knoxville and Fourth & Gill neighborhoods, but also the First Creek Greenway.

As noted in the awards ceremony, residents from all three neighborhoods "took a property that was dark, a little unnerving, and littered and transformed it with art in the form of a public

mural.” The names of the three neighborhoods and brightly colored graphics are now emblazoned on the walls and columns of the underpass.

9. City Council Reschedules One December Meeting

Knoxville City Council will not meet as scheduled on Tuesday, December 24, and instead will hold that meeting on Thursday, December 19, starting at 7 p.m. in the Main Assembly Room of the City County Building.

City Council meets every other Tuesday evening throughout the year, except on holidays (or holiday eves), when the meetings are rescheduled.

In addition, in accordance with the city charter, Mayor Madeline Rogero has called a special City Council meeting at 11:30 a.m. Saturday, December 21, for the purpose of electing the vice mayor, chair of the beer board, and Council representative to the board of the Knoxville Transportation Authority (KAT). Currently holding those offices are Nick Pavlis, Brenda Palmer, and Daniel Brown, respectively.

10. City Prepares for Icy Road Conditions

Winter is approaching --- and with it the possibility of icy road conditions --- so members of the city's Public Service Department recently completed annual snow and ice training, and the department has posted its snow plan (<http://www.cityofknoxville.org/services/snow.asp>).

The plan, updated during the fall of each year, details how the City responds to various types of snow and ice events, how it prioritizes City streets for treatment, and which resources the department can use to combat winter storms. Also included are maps and a list of frequently asked questions about how the city responds to snowy conditions.

The plan outlines how the city chooses which streets to clear or treat first. For example, the plan defines the top-priority Level I streets --- the ones carrying the greatest volume of traffic or that serve hospitals.

"Depending on the type of weather, we have up to 180 employees and 21 pieces of equipment ready to deal with it," said Public Service Director David Brace. "The snow plan gives us a template for setting priorities and letting everybody know what to expect."

Prior to an anticipated snow event, city crews typically pre-treat streets with a salt brine solution, which helps prevent snow from bonding with the road surface and lowers the melting point. Depending on the weather, pre-treatment can occur up to 48 hours prior to a snow or ice event and can be done at night or during non-busy traffic periods.

In addition to focusing on keeping main routes open during storms, crews also respond to calls from the Knoxville Police Department and Knoxville Fire Department for emergency services.
