1. Last Neighborhood Grants Workshop is This Saturday

The second and last pre-application workshop for the Neighborhood Small Grants Program (NSGP) will be held from 10-11 a.m. this coming Saturday, January 30, at United Way, 1301 Hannah Avenue. See directions below.

The session will start promptly at 10 a.m. but may run longer than one hour depending on questions. Office of Neighborhoods staff will stay as long as anyone has a question.

If your neighborhood organization was not represented at the Jan. 14 workshop, you must send a representative to the Jan. 30 workshop in order to submit an application. (The Jan. 30 workshop was rescheduled from Jan. 20 due to icy roads.)

Grant applications are due March 14, and awards will be announced in May for projects starting in July. The City is allocating up to \$43,000 for the grants program this year. Neighborhood groups can apply for grants ranging from \$500 to \$3,000. To enhance the impact of the city's funding, grants must be matched with volunteer labor and, depending on the project, donated goods and services or other monetary donations.

The [grant guidelines](#) and the [application form](#) are available on the city's website. Please note that many questions can be answered by reading the guidelines and looking over the application. Both the guidelines and the application will be reviewed at the workshops.

Grant funds can be used for projects and programs developed by resident-led, resident-controlled neighborhood associations, tenant associations, homeowners associations, and neighborhood watch groups that serve neighborhoods inside city limits. Start-up neighborhood groups may also apply.

3. Daryl Arnold to Keynote Neighborhood Luncheon

Daryl Arnold, pastor of Overcoming Believers Church in Knoxville, will keynote the **Neighborhood Awards and Networking Luncheon** on Saturday, March 5, at the Knoxville Convention Center.

Arnold is a member of the advisory committee for Knoxville's [Save Our Sons](#) initiative, which works with community partners to address persistent opportunity gaps and to eliminate violence-related deaths among boys and young men of color. He hosted a community forum in the days following the tragic events of mid-December, when Zaezion Dobson, a student at Fulton High School, was gunned down protecting his friends ([Dec. 29, 2015 Advisory](#)).

The luncheon will also feature remarks from Mayor Madeline Rogero as she presents the Neighborhood Achievement Awards and the Diana Conn Good Neighbor of the Year nominees and award winner.

The event begins at 10 a.m. with an opportunity for neighborhood leaders and other citizens to meet one another and talk shop with the Mayor and many of the city's department heads. Over 18 booths will dispense information on a broad array of city services.

From 11 a.m. until noon, the "Bringing It All Back Home" Community Showcase will feature six to eight slide show presentations of neighborhood, community and city-wide projects that address issues, concerns and opportunities in Knoxville.

Following the luncheon, there will be drawings for door prizes. Registration is now open for this event. (See next two articles.)

7. Better Building Board Meets Thursday

Five properties are on the agenda for this week's Better Building Board (BBB) meeting at 3:30 p.m. Thursday, January 28, in the Small Assembly Room of the City County Building.

The five properties on the agenda for certification of blight are: 229 Ailsie Drive, 2538 Davenport Road, 3960 W Bellemeade Avenue, 338 East Moody Avenue, and 5620 Sierra Road. Neighbors affected by these properties may wish to be present to testify on their impact on the neighborhood.

Under the city's Chronic Problem Properties ordinance, a property first determined and then later certified by the BBB to be blighted can eventually be acquired by the City, using its eminent domain powers, if the owner fails to take corrective action.

Blighted properties acquired by the city are listed for sale through Community Development's Homemaker's Program. See: http://knoxvilletn.gov/government/city_departments_offices/community_development/homemaker_program/.

A new property --- the house at 3037 E. Fifth Avenue --- has recently been added to the Homemakers list of available properties. This craftsman style duplex --- built in the early 1920's --- is appraised at \$35,000.

8. Testify on Blighted Properties at Meeting Friday

Seventeen properties are on the agenda for the City's next Public Officer Hearing at 9:30 a.m. Friday, January 29.

The Public Officer --- Public Works Director David Brace --- will hear testimony on buildings that inspectors contend are in violation of the city's building codes. Testimony can also be made by the property owners, neighbors, neighborhood groups, and other stakeholders, such as lien holders.

The Public Officer then decides whether to issue an order requiring that the violations be addressed within a certain period of time. Failure by the owner to cure the problem may result in the boarding or demolition of a structure, or the cleanup of a dirty or overgrown lot, with costs billed to the owner. A property owner may appeal the Public Officer's decision to the Better Building Board and, ultimately, to Chancery Court.

The properties to be heard for repair/demolition orders are: 1233 Connecticut Avenue, 2908 Dewine Road (including accessory structures), 4330 Galbraith School Road (including accessory structure), 2430 East Glenwood Avenue, 2815 Johnston Street, 645 Mars Hill Road (including accessory structures), 1131 Massachusetts Avenue (including accessory structure), 3345 Midway Street (including accessory structure), 2003 Nandina Drive (Pool only), 315 East Quincy Avenue, 2918 Selma Avenue, 5613

Wallwood Road (accessory structure only), 612 Washburn Road (including accessory structure), 3019 Wimpole Avenue.

The structure at 1307 West Baxter Avenue will be considered for confirmation of a previously issued emergency repair/demolition order.

If any of these properties are in your neighborhood, you or a representative of your organization may wish to attend the meeting to submit testimony about the impact of the property on the neighborhood.

9. Monday, Feb. 1, is Final Day to Register to Vote

The 2016 Presidential Primary Election and the Knox County Primary Election will be held March 1, with early voting taking place between February 10 and February 23. Next Monday is the last day to register for these primary elections.

Here are the candidates who are on the ballot for Knox County Commission, county-wide offices and Knox County Board of Education:

Commission District 1 candidates are Michael Covington (R), Evelyn Gill (D), and Rick Staples (D). City neighborhoods in District 1 include Lonsdale, Mechanicsville, Fort Sanders, Downtown, East Knoxville, Chilhowee Park, Parkridge, Burlington, and Holston Hills.

Commission District 2 candidates are Michele Carringer (R), John N. Fugate II (R), Laura K. Kildare (D), and Cheri Siler (D). (Siler has since announced she will not campaign.) City neighborhoods in District 2 include Fourth and Gill, Old North, Oakwood/ Lincoln Park, Inskip, Fountain City, North Hills, and Fairmont/ Emoriland.

Commission District 4 candidates are Hugh Nystrom (R), Jeffrey C. Ownby (R), Janet Testerman (R), and Marleen Kay Davis. City neighborhoods in District 4 include Sequoyah Hills, Deane Hill, West Hills, and Bearden.

Commission District 5 candidates are John Schoonmaker (R) and Sheri Ridgeway (D). District 6 candidates are Brad Anders (R), John Ashley (R), and Donna G. Lucas (D). District 8 candidates are Dave Wright (R) and Donald M. Wiser (I).

Commission District 9 candidates are Carson Dailey (R), James "Brandon" Hamilton (D), and Tom Pierce (I). City Neighborhoods in District 9 include: Island Home, Old Sevier, Lake Forest, Vestal, Lindbergh Forest, South Woodlawn, Colonial Village, and South Haven.

Assessor of Property candidates are Andrew E. Graybeal (R), Jim Weaver (R), and John Whitehead (R). The candidates for Law Director are Richard “Bud” Armstrong (R) and Nathan Rowell (R).

The candidates for the Knox County Board of Education are Jennifer Owen and Grant Standefer, District 2, Tony Norman, District 3 (unopposed), Lori Ann Bourdreaux and Susan Horn, District 5; and Michael McMillan, District 8 (unopposed).
