1. New Neighborhood Group Elects Officers

RiverHill Gateway Neighborhood Association, a new neighborhood organization in downtown Knoxville, elected officers last week.

Slated to serve for 2016-2017 are Kaye Bultemeier, president; Pia Serspinski, vice president; Dana Dalton, secretary, and Noel Kuck, treasurer. Zibbie Kerin and Andy Bowers will share the communication director position.

Also serving are Dee Pierce, representative to the Central Business Improvement District and the neighborhood emergency contact; Patty Rose and Ellen Johnston, fund-raising; and Dana Dalton, Dana Hart and Ellen Johnston, neighborhood grant committee.

Meanwhile, RiverHill is urging its members and others to donate to the Medic blood drive that will take place from noon to 4 p.m. Thursday, Feb. 4, at the Women's Basketball Hall of Fame, 700 Hall of Fame Drive. 2. West Haven, Norwood to Sponsor Candidate Forum

The **West Haven Village Neighborhood Association** and the **Norwood Homeowners Association** are co-sponsoring a forum for candidates running for School Board District 3, Knox County Commission District 6, Knox County Law Director and Knox County Property Assessor. A member of the news media will moderate.

The forum will be held from 6 p.m. to 7:30 p.m. Tuesday, Feb. 9 (one day before early voting begins), at New Hope Presbyterian Church, 1705 Merchants Road. (The church

is the red brick building located between the Expo Center and Norwood Elementary School on Merchants Road.)

“Both the sponsoring groups are nonpartisan,” noted West Haven President Vicki Forester in an email. “We do not endorse candidates for office or support a political party. We are holding this forum to allow citizens to meet and hear in person candidates for these important offices. We will do everything possible to be fair to all candidates.”

3. Eleven Nominated for Good Neighbor of the Year

Eleven Knoxville neighborhood residents were nominated for the Diana Conn Good Neighbor of the Year Award, and they will be honored at the City of Knoxville’s Neighborhood Awards and Networking Luncheon on Saturday, March 5, at the Knoxville Convention Center.

The day gets underway at 10 a.m. with an opportunity for neighborhood leaders and other citizens to visit the information booths, meet one another and talk shop with the Mayor and many of the city's department heads.

From 11 a.m. until noon, the "Bringing It All Back Home" Community Showcase will feature six to eight slide show presentations of neighborhood, community and city-wide projects that address issues, concerns and opportunities in Knoxville.

A free entrée salad will be served starting at noon. The program will include a keynote speech by Pastor Daryl Arnold of Overcoming Believers Church, followed by the presentation of the Neighborhood Achievement and Good Neighbor of the Year Awards.

5. Thursday is Final Day for Public Comment on Magnolia Streetscapes

The City of Knoxville's Department of Redevelopment will take public comment for another few days on proposed design details for streetscape improvements to the model block section of Magnolia Avenue between Jessamine and North Bertrand streets.

Some of the proposed improvements include raised medians to replace the center left-turn lane; bike lanes; improved sidewalks; bus pull-offs; and streetscape amenities such as street lighting, benches and bike racks.

A two-week public comment period following a January 21 public meeting runs through Thursday, Feb. 4.

6. Call Saturday Hotline for Possible Codes Violations

Most city residents know to call 311 during business hours from Monday through Friday to report potholes, overgrown lots, blighted buildings, broken sidewalks and other issues needing the attention of city government.

But what about the weekends?

There is now an answer to that question --- the Saturday hotline, a complaint-driven service to address concerns about possible zoning violations and non-permitted construction that may be taking place on the weekends but not on week days.

Just call 865-755-2531 between 8 a.m. and 4:30 p.m. on Saturdays. A City inspector will answer and visit sites of concern.

During weekday business hours, property owners unsure about commercial construction permitting can call 311 to speak with Plans Review and Inspections office staff. Business owners also can contact Patricia Robledo, the City's Business Liaison in the Office of Business Support, at 865-215-3155.

For residential construction projects, citizens can check a list of items that require permitting by visiting www.knoxvilletn.gov/plansreview or by calling 311 during regular business hours.

7. Applications Due Feb. 26 for Community Agency Grants

The City of Knoxville is currently accepting applications from nonprofit organizations interested in obtaining a City Community Agency Grant for Fiscal Year 2016-17, which begins on July 1, 2016.

Please Note: These Community Agency Grants are different and separate from Community Development grants (see article below) and the [Office of Neighborhoods grants](#). All of these grant programs are currently in play, with applications due in February or March.

The deadline for filing a Community Agency Grant application is 4 p.m. Friday, Feb. 26, 2016. The City will not consider any application received after that time. To apply for a grant, the non-profit organization must operate within the City of Knoxville and must have been in operation for at least five years.

There are two different application forms. One is for organizations seeking a grant within the "Arts and Culture" category, and the second is for organizations seeking a grant within the Community and Social Services category.

Priority in awarding will be given to proposals that contribute to the goals and mission of the City of Knoxville.

"Nonprofit organizations contribute so much to the vitality of our city," said Indya Kincannon, Special Projects Manager for the City of Knoxville. "We are happy to contribute to their efforts."

8. Community Development to Accept Funding Applications

The City of Knoxville's Community Development Department this month will accept applications for projects that will be supported by local, state and federal funds in the program year beginning July 1, 2016.

The application process will begin Friday, Feb. 5, 2016, when the department posts application documents on its website at www.knoxvilletn.gov/development. Starting Friday, just click on "Community Development Block Grant and Homeless Grant" at the top of the web page.

There are two main funding programs in this round.

First, the Community Development Block Grant (CDBG) is a U.S. Department of Housing and Urban Development (HUD) grant program that funds activities that primarily benefit low and moderate income persons/households and areas in the City of Knoxville.

Proposed activities must meet a high priority need under the city's 2015-2019 Five Year Consolidated Plan, which is available on the website listed above. (Click on "Reports and Plans" to see a copy of the 5-year plan.) These high-priority needs are strengthening neighborhoods, promoting economic development, reducing and ending homelessness, and promoting affordable housing.

Second, groups may apply for a homeless grant, funding for which comes from multiple sources – the City of Knoxville, Tennessee Housing and Development Agency (THDA) and HUD. This grant program funds activities in the City of Knoxville that meet the high priority need of reducing and ending homelessness.

Please Note: A mandatory Technical Assistance Workshop for all applicants will be held at the O'Connor Senior Center, 611 Winona Street, on Thursday, February 11, 2016, at 10:00 a.m. for CDBG applicants and 11:00 a.m. for Homeless Grant applicants. If the Feb. 11 meeting has to be cancelled due to weather, the alternate date is Feb. 16, same place and times.

All applications are due no later than noon on Friday, February 19, 2016, whether delivered by mail, FedEx or in person (no exceptions). Grant applicants must be nonprofit, 501(c)(3) organizations. Funds are distributed on a reimbursement basis only (no up-front funds). There are quarterly reporting requirements, an extensive monitoring process, and both environmental and insurance requirements that must be met.

9. MPC Sets Schedule for Updates to One-Year Plan

The staff of the Metropolitan Planning Commission will meet with interested city residents in three separate meetings this month to go over proposed changes to the city's One Year Plan and take public input.

These public meetings will be held on Feb. 11 for the East, North and Central sectors; on Feb. 16 for the West and Northwest sectors; and Feb. 23 for the South Sector. See details in the Neighborhood and Government Calendar below.

The [One Year Plan](#) is based on land use goals, objectives and policies found in such documents as the city's long-range [sector plans](#) and the [General Plan](#).

Based on a City Charter amendment adopted by voters in 1982, the land use policies contained in the One Year Plan form the legal basis for zoning decisions in the City of Knoxville for a 12-month period. The annual update incorporates changing community goals and One Year Plan amendments adopted in the previous year.

The schedule calls for MPC commissioners to consider the One Year Plan at its March 10 meeting, and for City Council to consider adoption on first and seconding readings on April 12 and 26.
