1. Watch Out for Scammers Claiming to be the City

We have been made aware that someone has been sending out emails that appear to come from a KnoxvilleTN.gov email address. The email asks you to click to access a secure message.

The City will never send an email that you can only access by clicking on links, opening secure messages, attachments, or providing credentials of any type.

If you have any doubt as to the legitimacy of a City email, please call the department sending the email. Remember to look up the phone number of the City department. Do not call the number listed on the email as that may go to the imposter.

It is better to check with one of us than to try opening something that can affect your computer/phone/tablet.
