IV. Vision Zero Presentation: Brian Blackmon, Director CoK Sustainability Office

Blackmon presented on Vision Zero and presented a series of questions to be discussed and answered by the CODI body:

1. Do you feel Knoxville's streets are safe and accessible?

- 2. What specific safety issues/concerns/problems have you experienced on Knoxville's streets?
- 3. Which of the following do you agree with?
 - a. I support reducing speed limits
 - b. I support increasing street amenities (street lighting, street trees, public art, sidewalks, etc.)
 - c. I support adding pedestrian facilities (high-visibility crosswalks, mid-block crossings, sidewalk connections, etc.)
 - d. I support adding bicycle facilities (separated bike lanes, merging lanes, new bikeway connections, etc.)
 - e. I support removing traffic lanes or restricting on-street parking to install improvements
 - f. I would be willing to add time to my commute for safety
- 4. Are the "rules of the road" (traffic laws) clear in Knoxville?
- 5. Do you have any final thoughts on what could make your transportation experience better?

Various members gave differing opinions on what changes could benefit Knoxville.

a. Nancy Carter presented on the lack of access for those with visual disabilities to Learn Screen Reading Software.

X. Announcements and Public Forum

a. Carol Sutton, public forum speaker

Spoke of the recent incident between KPD, Fort Sanders Regional Medical Center, and Lisa Edwards that ultimately culminated with the untimely death of Ms. Edwards. Ms. Sutton implored CODI to offer training for KPD and/or the hospital to prevent this type of situation from happening again.

Cook explained that, while she will not comment on an ongoing investigation, CODI is a body of volunteers that report to the Mayor via

Disability Services Office staff, and that the hospital is a private entity. She also mentioned that a number of CODI members have provided training with the KPD on engaging with the disability community in Knoxville.

b. Christy Frazier, public forum speaker

Spoke of her experience as a person who is deaf and homeless. She reported that she has repeatedly failed to have interpreters provided for her at various locations and has struggled to get help with housing. She further stated that at shelters she has tried to stay at, she would be separated from her eight-year-old son who is autistic, and expounded on issues she has experienced during his schooling related to both of their disabilities. She is looking for resources or help related to finding stable housing in Knoxville and being able to have her children back with her.

- c. Light Up for Blue event created by the Tennessee Disability Coalition coming up on March 11, 2023.
- d. The "Get Happy" video recording will be Wednesday, March 15, 2023, at 11:00 a.m. If you are able and willing to attend, please arrive at Suite 539 of the City County Building no later than 10:50 a.m. that day.
