

# **MINUTES OF THE REGULAR SESSION OF THE COUNCIL OF THE CITY OF KNOXVILLE**

**MAY 4, 2010 - 7:00 PM  
Main Assembly Room, City-County Building**

## **1. CALL TO ORDER**

The Council of the City of Knoxville met in Regular Session at 7:00 p.m. in the Main Assembly Room of the City-County Building.

Mayor Bill Haslam was present and presiding officer of the Council.

## **2. INVOCATION AND PLEDGE OF ALLEGIANCE TO THE FLAG**

Councilmember Woodhull led in the Invocation and Councilmember Della Volpe led in the “Pledge of Allegiance” to the Flag.

## **3. ROLL CALL**

The following Council Members were present: Joe Bailey, Vice-Mayor Bob Becker, Daniel Brown, Nick Della Volpe, Duane Grieve, Brenda Palmer, Nick Pavlis, Marilyn Roddy and Chris Woodhull.

There were no members absent.

## **4. APPROVAL OF MINUTES**

Councilmember Pavlis made a motion to approve the minutes from the April 20, 2010 City Council meeting. Councilmember Brown seconded the motion. By unanimous voice vote the motion carried. The minutes were approved.

**VICE-MAYOR BECKER ACTED AS PRESIDING OFFICER DURING THE DISCUSSION OF ORDINANCE 12F.**

**RE: CITY CODE AMENDMENT – ZONING REGULATIONS ARTICLE V, SECTION 10 – CHANGEABLE PRICE SIGNS**

- 12-f.** An Ordinance to amend the Knoxville City Code, Appendix B “Zoning Regulations,” Article V, Section 10 regarding the minimum required street frontage for the installation of a changeable price sign to require a minimum of 100 feet of frontage on the street where the property is addressed. (MPC Approved 10-0-1) (File No. 12-A-09-OA)

Councilmember Roddy made a motion to approve the ordinance on first reading. Councilmember Woodhull seconded the motion.

Discussion ensued with the following persons speaking: Chuck Baine, owner of Breadbox Convenient Stores, in favor of ordinance; Councilmember Della Volpe, Councilmember Grieve, Joyce Feld, Scenic Knoxville, in opposition to ordinance, Vice-Mayor Becker, Councilmember Roddy, Public Works Director Steve King, Buz Johnson, MPC, Councilmember Bailey, Councilmember Pavlis, Councilmember Brown, Councilmember Palmer.

Councilmember Brown made a motion to call the question. Councilmember Roddy seconded the motion. Upon roll call, Councilmembers Brown, Palmer, Roddy and Woodhull voted “Aye.” Councilmembers Bailey, Becker, Della Volpe, Grieve and Pavlis voted “Nay.” The motion failed.

Discussion continued with Councilmember Bailey and Mr. Baine speaking.

Vice-Mayor Becker made a motion to refer the matter back to MPC for them to explore ways to reduce street frontage and reduce sign clutter by reducing sign size. Councilmember Grieve seconded the motion.-

Councilmember Roddy made a substitute motion to amend the 100 feet of frontage to 150 feet of frontage. Councilmember Palmer seconded the motion.

Discussion followed with Councilmember Roddy, Charles Swanson, Buz Johnson, Councilmember Della Volpe, Councilmember Grieve, Councilmember Pavlis, Councilmember Woodhull, Vice-Mayor Becker and Councilmember Palmer speaking.

Councilmember Palmer made a precedent motion to postpone the matter six (6) weeks. Councilmember Grieve seconded the motion. Upon roll call, Councilmembers Bailey, Becker, Della Volpe, Grieve, Palmer, Pavlis and Woodhull voted "Yea." Councilmembers Brown and Roddy voted "Nay." The motion carried. The ordinance was postponed six (6) weeks.

Councilmember Grieve made a motion to approve the ordinance on first reading. Vice-Mayor Becker seconded the motion. By unanimous voice vote the motion carried. The ordinance was approved on first reading.

- 12-o.** An Ordinance to rezone property located on the northwest side of Deane Hill Drive, southwest side of Wellsley Park Road from RP-1 (Planned Residential) District at a density of 24 dwelling units per acre and RP-1 (Planned Residential) District at a density of 6-14 dwelling units per acre to RP-1 (Planned Residential) District at a density up to 19 dwelling units per acre and establish the entire site as one zoning district, Wellsley Land Partners, G.P., Applicant.
