SUFFRAGE AMENDMENT ADOPTED BY HOUSE

WARSAW SAVED; POLES DRIVE FURTHER BACK
Troops of Pilsudski, Now on Offensive, Win New Positions.
RED PEACE TERMS ARE READ POLISH MISSION

RATIFICATION ACCLAIMED BY PARTY HEADS

WARSAW, Aug. 18.—Warsaw is saved unless the unforeseen happens. Poland, contrary to all expectations, even of the most pro-Polish observers, has duplicated the first battle of the Marne, by which Paris was saved in September, 1914. The dramatic turn in the tide is now being developed into a counter-offensive against the Red armies on an extended front to the north and the southeast of Warsaw. The military talk has turned from the problem of defense to aggression. The optimists can see a complete rout of the Red armies and the restoration of the Polish lines to the points on which it rested prior to the retreat.

WASHINGTON, Aug. 18.—Ratification of the suffrage amendment by the Tennessee Legislature was hailed with great joy in the capital. Government officials and leaders of the suffrage movement joined in the celebration.
Secretary of State Colby, upon whom rests the final act of proclamation, all that is needed to confer the voting privilege upon 26,500,000 women citizens, announced that he would act at the earliest possible moment.
Ordinarily the practice has been to wait for official certification by the Secretary of State of the last state ratifying a constitutional amendment before proclaiming it to be in effect. Secretary Colby said that unless unforeseen complications arise he will follow this custom.

FRENCH NOTE TO U. S. INDORSES POLISH STAND

Nations in Agreement in Principle, Says Secretary of State Colby.
WASHINGTON, Aug. 18.—The American and French governments are in entire agreement in principle as to the future of both Poland and Russia, Secretary Colby declared today in a formal statement interpreting France's rejoinder to the American note to Italy. His statement accompanied publication of the translation of the French note which was delivered to the State Department on August 14 by Prince de Baux, the French charge.

VOTES FOR WOMEN SEEN AS AID FOR GOVERNOR COX
Democratic Leader and His Friends Hail Action of Tennessee Assembly.

COLUMBUS, O., Aug. 18.—Governor Cox and his aids joined today in hailing Tennessee's ratification of the woman suffrage amendment. That the enfranchisement of women would help the Democratic presidential and local tickets was predicted universally by the Governor's advisors, who said they believed a great majority of women stand with Governor Cox on the League of Nations issue.
