Blighted Property Redevelopment Program (BPRP)



- Provides 0% repayable loan with 5% match to renovate blighted unoccupied residential structures.
- Eligible structures, are those that are:
 - Listed on the City's Homemakers Program;
 - Listed on Knox Heritage's Fragile and Fading List;
 - Determined blighted by the Better Building Board; or
 - Placarded as "unfit for human habitation" by City Neighborhood Codes Enforcement.

Construction / Housing Rehab Programs



- Loans, grants, and technical assistance to help low-to-moderate income homeowners and landlords of affordable rental units make major repairs that meet the Neighborhood Housing Standards. Funds are also available to assist in the development of affordable rental units.
- Opportunities: Comprehensive residential rehab, new construction, and lead-based paint abatement contracts.
- All contracts are between the property owner and contractor.

Lead-Safe & Healthy Homes Program



- Grants and technical assistance to help income-qualified homeowners and landlords of affordable rental units identify and remediate lead-based paint hazards in pre-1978 housing.
- Grants up to \$20,000 per unit.
- Opportunities: Lead-based paint (LBP) abatement contracts and training opportunities. State of Tennessee LBP credential reimbursement funding available.

Commercial Façade Improvement Program

\$12,500 - \$49,999: Minimum of 3 quotes - typically posted on website for 1 week

Below \$12,500: Departmental discretion

Service Contracts valued at \$20,000 or greater require approval by the Knoxville City Council

Purchasing Procedure



- 1. Department submits a request to the Purchasing Office for the goods or services needed
- 2. The Purchasing Division posts a solicitation for the request
- 3. Registered vendors receive notification
- Purchasing responds to written questions and holds pre-bid meetings. Questions are answered via publicly posted addendum.
- 5. Sealed Bids and Proposals are opened @ 11:00 a.m. on the deadline date
- 6. Quotes are reviewed @ 2:30 p.m. on the deadline date
- 7. Bid Tabulations are posted to the website
- 8. Submissions are evaluated
- 9. Awards are made to the bid or proposal which represents the best value to the City.

How to Compete



- Register online as a vendor with the City. Registration is free
- Follow our social media BizWithCityKnox



- Review previous successful solicitations but do your homework on current pricing
- Visit our website www.knoxvilletn.gov/bids often to see active bids and other solicitations
- Attend pre-bid meetings important opportunity for subcontractors as well
- Make note of the deadline for questions & submit written questions when unsure of requirements
- Attend bid openings in-person or via Zoom to gain knowledge
- Get insured or bonded & stay current on insurance, certifications, licenses, bonding, etc.
- Submit bids on time Bids and Proposals received after the deadline will be rejected
- Insure your bid meets specification and price your product/service competitively





Construction Specific

- 1. Be licensed to conduct business in State of Tennessee
- 2. Be prepared to submit bid bond (5%) for projects > \$100K
- 3. Prepare for performance & payment bond submission (100%) projects > \$25K



- HRA Highway, Railroad, & Airport Construction certified. Note the difference between full HRA and subclassifications
- MU Municipal & Utility Construction Base & Paving license
- CE Electrical Contracting
- 5. Be certified with TDOT when planning to conduct highway projects
- 6. Prime Contractors are responsible for ensuring sub-contractors are properly licensed
- 7. Obtain the required insurance
 - Commercial general liability \$2M Occurrence/\$3M Aggregate
 - Auto liability (\$1M per occurrence)
 - Workers' compensation with statutory limits & Employers' liability with limits of \$500K minimum
 - Additional coverage for Professional Liability (\$2M), Pollution Liability, Environmental, Cyber Liability (\$5M)



The Award Process



Purchase Orders

- Issued for products and small services resulting from Requests for Quotes & ITBs
- Evaluated by best value to the City
- Usually awarded within a week of submission deadlines

Formal Contracts

- Issued for complex services and construction resulting from ITBs, RFPs, RFQs & LOIs
- May require evaluation of price and other criteria
- Timeline can be long
 - may require negotiation, insurance certifications & endorsements, legal review and City Council approval.





- KCDC oversees approximately 26 housing developments
- KCDC has expanded its role to serve as the public housing for the City of Knoxville and Knox County
- KCDC is the redevelopment authority for Knoxville



Summary of General Information

- KCDC has approximately 3,600 apartments
- KCDC has approximately 149 employees
- KCDC contracts out most services
- KCDC buys items to maintain its apartments and its offices
- KCDC relies on "term bids" to meet its needs
- Increasing using multiple awards to meet our needs

Quotations

- Expenditures >\$20,000 and <\$50,000 are quotes
- Procurement often assigns a quote number and posts the document to the KCDC web page
- Quotes must be received from at least three qualified firms
- May not be very complex
- Formal sealed bidding rules do not apply



Formal Solicitations

- Over \$50,000, KCDC uses formal bids to meet the legal requirements imposed by State and Federal Governments
- Procurement will assign a bid number and post the bid to the web page
- The length and complexity of the document will vary with the procurement need

- PBA manages over 2 million square feet of buildings for the City and County.
- PBA originally developed and owns the City County Building, which is approximately 531,000 square feet in size.
