I understand that neither the City of Knoxville nor any of its instrumentalities, agents, or employees makes any representations as to continued rights to keep, sell, or maintain Vietnamese Pot Bellied Pigs within the City of Knoxville or to extend the duration of the permit or grant additional permits in the future. I absolve the City of Knoxville of all liability flowing from any damage or harm that I or another granted authority under this permit might cause, by negligence or otherwise, in the enjoyment of the privileges granted therein. I assert that I have read and understand the relevant provisions of the City Animals Ordinances in Chapter 5 of the City of Knoxville Code and agree to comply with all relevant provisions of those ordinances governing the treatment, sale, transport, and care of the animals in question and understand the criminal and civil consequences of violating those ordinances. further understand that, in the event of a public health emergency, I agree to immediate compliance with directions of public health officials and agree to allow those officials to enter, seize control, and/or close my operations if a situation threatening the public health develops or is discovered.
