Parcel 120IA010 is currently a single lot with two buildings. The lot is to be subdivided into two lots each containing an existing building. The southern building currently houses a United Stated Department of Veterans Affairs medical facility. The facility is planning to expand in the future to adequately support the East Tennessee veteran community. The City of Knoxville Zoning Administrator had determined the southern face of the northern building is required to meet the front setback per Article 5 Section 5.3 Table 5-1. The majority of the northern buildings access points face the north (toward the interstate). The variance requests the front setback to be reduced to zero feet.						
Describe hardship conditions that apply to this variance. Existing easements along the west side of the facility, a tapered ROW along the east of the facility, and existing infrastructure south of the facility prevent expansions leaving expansion to the north as the optimal option.






