# 2. Parkridge Leads Registrations for The Neighborhood Conference

More than a dozen people from the Parkridge Community Organization (PCO) have signed up for The Neighborhood Conference, including most of the group's board of directors.

PCO has the right idea: Neighborhood organizations should try to encourage members and neighbors to attend, not only to cover as many of the 32 workshops as possible, but also to gain skills in planning events, raising and managing money, fighting crime, working with local government, settling disputes between neighbors, and more.

Hosted by the city's Office of Neighborhoods in cooperation with Knox County and a planning committee of neighborhood representatives, the conference will be held on Saturday, March 23, at the Knoxville Convention Center. Doors open at 7:30 a.m., and Mayors Rogero and Burchett make welcoming remarks starting at 8:30 a.m.

- \*\*\* The conference ends at 3 p.m. after a drawing for door prizes. Door prize tickets are obtained by participating in the workshops.
- \*\*\* As reported last week, South Haven Neighborhood Association is challenging other neighborhood groups to a t-shirt contest. Awards will be made to both city and county neighborhood organizations for the best silk screen t-shirt and the best homemade t-shirt. There will be a separate category for best t-shirt made by an individual in an unorganized neighborhood. T-shirts will be judged on creativity communicating neighborhood pride and/or promoting the neighborhood.

The Bloomberg Philanthropies Mayors Challenge offers one \$5 million award and four \$1 million awards for innovative local solutions to national problems. Last fall, Knoxville was announced as one of 20 finalists from 305 cities that applied. The City's proposal calls for

creation of a unique business model that encompasses the entire urban food cycle by connecting land, farming jobs, processing facilities, food transit, sale, and composting.

## 4. City Seeks Candidates for Neighborhood Advisory Council

The Office of Neighborhoods is seeking expressions of interest from leaders and participants in neighborhood organizations who may want to serve on the Neighborhood Advisory Council (NAC), which advises the city administration on neighborhood-related issues.

Appointed by the Mayor, the NAC is composed of two neighborhood leaders from each of the six City Council districts and at least three at-large members. Currently there are 15 seats on the NAC. The terms are for three-years, and one third of the seats are up appointment or reappointment each year.

After many years of service, four NAC members --- Whitney Stanley, Jody Mullins, Barbara Armstead and Polly Doka --- are cycling off NAC at the end of March:, therefore seats 1-B, 3-A, 5-B and At-Large A are open. Members appointed to the district seats must live in that City Council district; at-large members can live anywhere in the city.

# 5. Friday, March 1 is a Tree-Mendous Day

The City of Knoxville Tree Board and the State of Tennessee Dept. of Agriculture are sponsoring an Arbor Day celebration at 10 a.m. Friday, March 1, at Ijams Nature Center.

Arbor Day is a national celebration of trees, and a time to encourage everyone to plant trees. Dubbed "Tree-Mendous Day" in Knoxville, the celebration will include remarks by Knoxville Public Works Director Christi Branscom and Tennessee Commissioner of Agriculture Julius Johnson.

The city will be presented with Tree-City and Tree Line USA awards, and there will also be a student presentation by Nature's Way Montessori School. David Vandergriff, chair of the tree board, will preside, and light refreshments will be served.

## 6. Neighbors Can Testify on Blighted Properties Next Week

Twenty-one residential properties and two commercial properties are on the agenda for the City's next Public Officer Hearing at 9:30 a.m. Friday, March 1.

The Public Officer --- David Brace, director of the Public Service Department --- will hear testimony on buildings that inspectors contend are in violation of the city's building codes. Testimony can also be made by the property owners, neighbors, neighborhood groups, and other stakeholders, such as lien holders.

The Public Officer then decides whether to issue an order requiring that the violations be addressed in a certain period of time. Failure by the owner to cure the problem may result in the boarding or demolition of a structure, or the cleanup of a dirty or overgrown lot, with costs billed to the owner.

A property owner may appeal the Public Officer's decision to the Better Building Board and ultimately to Chancery Court.
