## 1. Neighborhoods to Celebrate Sixth Avenue Mural Saturday

Mayor Madeline Rogero will help three Knoxville neighborhoods celebrate the completion of the Sixth Avenue Mural Project this Saturday, August 24.

The festivities will take place from 11 a.m. until 2 p.m. underneath I-40 as it crosses Sixth Avenue and the First Creek Greenway, near Glenwood and Sixth.

Music will be provided by local DJ Kate Furst, and the food will be prepared by Straight off the Grill and Peace by Piece.

The mural project was initiated by residents in the Parkridge neighborhood but quickly became a joint venture involving the historic neighborhoods of Fourth and Gill, Old North Knoxville, and Parkridge. Over 60 volunteers from the three neighborhoods installed the mural designed by local artist Per-Ole Lind.

# 2. Deadline Next Week for Neighborhood Leadership Training

The Office of Neighborhoods is taking applications for a neighborhood leadership training program that will be offered for the first time this fall.

The program was created specifically for participants in, and leaders of, resident-led, resident-controlled neighborhood groups, as well as individuals who would like to start neighborhood associations in unorganized neighborhoods.

"Building Strong Neighborhood Organizations" (BSNO) is designed to address a wide variety of questions and concerns about starting and sustaining an effective neighborhood organization.

There will be one session per week on Thursday evenings, beginning September 5 and running through November 14, at the Knox County Health Department on Dameron Avenue.

Each of the 11 sessions will be two hours long, and a light meal will be provided. There is no fee, but participants will be strongly encouraged to attend every session except for personal or family illness.

### 3. City Council to Consider Tennova Request for Middlebrook Rezoning

Knoxville City Council will hold a workshop at 5 p.m. Thursday, August 29, to discuss details of the Metropolitan Planning Commission's recommendation that a site on Middlebrook Pike be rezoned from A-1 (agricultural) to O-1 (office).

Council is expected to question the applicant, Tennova Healthcare, which wants to build a new hospital on the site to replace its existing hospital next to Fulton High School in North Knoxville. Council workshops include public forums to gather citizen concerns on the specific workshop topic at hand.

## 4. Neighborhoods: Plan to Attend Emergency Preparedness Fair

Neighborhood leaders are encouraged to attend the Emergency Preparedness Fair at Cokesbury United Methodist Church, 9915 Kingston Pike, on Saturday, September 21, from 9:00 a.m. to 2:00 p.m.

Natalie recently joined the Office of Neighborhoods as an AmeriCorps associate, with primary responsibility for disaster preparedness in city neighborhoods. She replaces Eden Slater, who now works in the city's Community Development Department.

Voluntary Organizations Active in Disaster (VOAD) is hosting the fair in conjunction with emergency management professionals, agencies, and volunteers to teach and share knowledge on preparing the home, family, neighborhood, and community in case of emergency. This event drew over 1,500 participants last year.

The fair includes classes, demonstrations, and information booths on a wide variety of topics, including senior citizen care; pet emergency essentials; and basics on family preparedness, such as food storage, emergency communication, and more.

Participating organizations include the Knoxville Police Department, Knoxville Fire Department, Knoxville Emergency Management Agency, Tennessee Emergency Management Agency, Red Cross, Medical Reserve Corps, and numerous other organizations.

#### 5. MPC Schedules Second Round of East City Sector Plan Meetings

The Metropolitan Planning Commission (MPC) has scheduled two public meetings as it works toward revising the East City Sector Plan.

The first will be held at 6 p.m. Monday, September 30, at the Jacobs Building (second floor) at Chilhowee Park, 3301 Magnolia Avenue. The second one will take place at 6 p.m. Thursday, October 3, at Washington Pike United Methodist Church, 2241 Washington Pike.

At these meetings, MPC staff will present the draft plan and accompanying recommendations for the land use, community facilities, and transportation sections.

"To date, there has been a lot of interest in the plan," says MPC's Jeff Archer. "Staff has collected 181 completed surveys, and additional input was gathered at neighborhood organization meetings and at the first round of sector plan meetings held in June and July."

Archer said this public input has revealed that citizens in the East Sector: Want improvements to the sidewalk system and complete streets that better accommodate multiple modes of transportation, especially pedestrians and bicyclists. Want better design of their public spaces and private developments. Support mixed use developments on the major roadways.

Five incumbent members of City Council are up for reelection this year to additional four-year terms of office. They are:

Nick Pavlis, District 1, South Knoxville and UT/Fort Sanders Duane Grieve, District 2, West Knoxville Brenda Palmer, District 3, Northwest Knoxville Nick Della Volpe, District 4, Northeast Knoxville Daniel Brown, District 6, Central and East Knoxville

Nick Della Volpe has drawn an opponent in District 4 --- Rick Staples. And Pete Drew is running against Daniel Brown in District 6. Council members Pavlis, Grieve and Palmer are unopposed.

All of the candidates, including the incumbents who are unopposed, are expected to participate.

The primary election (vote within your Council district) is September 24. All registered city voters can vote in all of the Council races in the general election, which is Tuesday, Nov. 5.

#### 7. Community Development Seeks Action on Blighted Properties

The city's Better Building Board next week will take action on two properties that ultimately could be acquired by the city at fair market value using its eminent domain powers, if the owners fail to address codes violations.

Neighborhood groups may wish to be present to testify on the impact of these properties on the neighborhood. The BBB meets at 3:30 p.m. Thursday, August 29, in the small assembly room of the City County Building.

The properties include a parcel with a blighted structure at 434 East Quincy Avenue and a vacant lot on Candler Avenue.

The BBB – composed of five citizens appointed by the Mayor – will be asked to either "determine" or "certify" that the properties are blighted based on criteria spelled out in a city ordinance. These are the first steps toward the city possibly acquiring the properties at fair market value, if the owner fails to take steps to cure the blight.

#### 8. Neighborhoods Can Testify on Blighted Properties

Twenty two residential properties and one commercial property are on the agenda for the city's next Public Officer Hearing at 9:30 a.m. Friday, August 30.

The Public Officer --- David Brace, director of the Public Service Department --- will hear testimony on buildings that inspectors contend are in violation of the city's building codes. Testimony can also be made by the property owners, neighbors, neighborhood groups, and other stakeholders, such as lien holders.

The Public Officer then decides whether to issue an order requiring that the violations be addressed in a certain period of time. Failure by the owner to cure the problem may result in the boarding or demolition of a structure, or the cleanup of a dirty or overgrown lot, with costs billed to the owner. A property owner may appeal the Public Officer's decision to the Better Building Board and ultimately to Chancery Court.

Several properties have already been served with emergency repair or demolition orders, and the Public Officer will hear testimony on whether to confirm those orders. These are: 2715 Addison Drive, 3902 Catalpa Avenue, 1700 Cedar Lane, 605 Citico Street, 4105 Holston Drive (a commercial structure), 2321 Laurinda Road, and 2823 Tecoma Drive, including accessory structure.

Here are the remaining residential properties to be considered for action: 2011 Glenn Avenue including accessory structure, 3817 Knott Avenue, 3122 Lay Avenue, 1629 Luck Avenue, 4416 McDonald Drive, 802 Phillips Avenue, 434 East Quincy Avenue, 2416 Ridgecrest Avenue, 1923 Saxton Avenue, 3726 Selma Avenue, 842 Vermont Avenue, 1721 Wandering Road including accessory structure, 1717 Washington Pike, 1824 Wilkins Street, 322 East Woodland Avenue including accessory structure, and 5100 Wyndcroft Drive.

If any of these properties are in your neighborhood, you might wish to consider sending a representative of your organization to the meeting to submit testimony about the impact of the property on the neighborhood.
