1. Beaumont Community Organization Plans Chili Supper

2. West Knoxville Neighborhood Has a New Name

If you were given the opportunity to name your neighborhood, what criteria would you use to generate the best name possible?

Residents of a West Knoxville neighborhood faced that question on a recent Saturday morning when they gathered to put a name on the neighborhood some of them had lived in for decades.

Located across Montvue Road from West Town Mall, the neighborhood of 107 homes has been listed on <u>www.kgis.org</u> as "West Hills (South)" and for good reason. It was created around the same time, and apparently by the same developers, as the much larger and better known West Hills neighborhood north of I-40. In fact, the property deeds for homes on Hayden Drive and connecting streets all mention "West Hills subdivision (Unit 10)."

Although "West Hills South" was the name of a neighborhood watch group years ago, neighbors at the meeting say they respond in different ways when asked, "What neighborhood do you live in?"

Back in 2012, a relatively new resident of the neighborhood, Kristi White, began contacting the Office of Neighborhoods, expressing concerns about a needed sidewalk (it's on the list), graffiti-covered storage trailers sitting on a commercial lot on Ray Mears Blvd. across from the neighborhood (they were illegal, and the owner removed them), and her dream for neighborhood signs at the five entrances leading into the neighborhood.

The signs were somewhat problematic. Without a neighborhood organization, there was no readily available means by which to agree on a neighborhood name that could then be placed on entrance signs. Eventually, Kristi and her husband Jerry, along with Megan and

David Erpenbach, decided to put their names and contact information on a flier calling for a community meeting to name the neighborhood.

At the meeting earlier this month, neighbors considered factors that make up a good name, such as: Is it inclusive? Does it express the neighborhood's unique character and location? Is it catchy, memorable and marketable? Is there buy-in from the neighbors? Will they use it when someone asks, "Where do you live?"

After brainstorming a variety of names, and carefully considering and combining the options long enough to bridge differences of opinion, the group decided unanimously that it wanted to keep "West Hills" in the name but to fix the location more precisely.

So... Welcome to "West Hills at Montvue" --- Knoxville's "newest" neighborhood!

3. COIN to Consider New Goals

COIN is discussing possible new goals at its regular monthly meeting on Monday, November 4, starting at 5:30 p.m. at the L.T. Ross Building, 2247 Western Avenue.

According to COIN, the possible new goals include 1) creating a network of neighborhood leaders who will consider a city-wide response if candidates who are not neighborhood friendly get elected to city office; 2) creating quarterly meetings for neighborhood leaders from different parts of the city to meet and interact: 3) creating a network of neighborhood leaders that will help create a clear description of the positions of neighborhoods on issues brought to the network; and 4) asking the neighborhoods for the major issues facing them and reporting the results to the city.

4. MPC Goes to Phase 2 for Rezoning in Inskip

The Metropolitan Planning Commission next Monday will conduct a public meeting to present plans for rezoning several residential portions of the Inskip community from R-2 medium density residential to R-1 or R-1A low density residential zoning districts.

The meeting will begin at 6 p.m. Monday, November 4, at Inskip Baptist Church, 4810 Rowan Road. MPC mailed notices about the meeting to affected property owners, and the Inskip Community Association is helping spread the word.

Last May, City Council asked MPC to review all residential land located within the Inksip neighborhood and to recommend whether portions should be rezoned to low density residential as a means to preserving the integrity, history and stability of the neighborhood.

"MPC staff proposed a phased approach to the potential rezoning to allow for a more

thorough review of properties being involved and to have a manageable number of property owners to contact in this regard," the MPC letter states. "Phase 1 was considered by MPC in August and approved by the Knoxville City Council on September 17, 2013."

Now MPC is moving forward on Phase 2 of the Council request, which covers three separate areas within Inskip, roughly described as:

** The triangle bounded roughly by Coster Road, Bruhin Road and Glenoaks Drive, plus several single family residential blocks extending north of Glenoaks.

** Single family residential streets between Central Avenue Pike and Fennel Road, and including E. Inskip Dr., Sylvia Dr., and Elyria Dr.

** The area that includes Coster Rd. north of E. Inskip, portions of Rowan Rd. between Cedar Lane and E. Inskip, and a half block of Scheel Road.

This process actually started in 2009, when City Council asked MPC to study the Inskip area for zoning and land use designation irregularities and to create a small area plan, which was adopted by City Council in March 2011. The Inskip Small Area Plan demonstrated that a majority of the area is still used for detached, single-family houses on individual lots, but the zoning is primarily R-2 multi-family residential.

"Such a discrepancy between land use and zoning can have destabilizing effect on a neighborhood, so the plan recommends rezoning large clusters of single-family houses from the R-2 (General Residential) district to either the R-1 or R-1A (Low Density Residential) district," explains the letter to property owners.

The rezoning is scheduled to go before the Metropolitan Planning Commission on Thursday, November 14, 2013 at 1:30 p.m. in the Large Assembly Room of the City-County Building. Questions may be directed to MPC staff members Mike Reynolds or Michael Brusseau at 215-2500.

5. Historic Knoxville High School Developers Set Two Design Meetings

Southeastern Housing Foundation and Family Pride Corporation --- the entities selected by Knox County to restore and repurpose Historic Knoxville High School --- will host two design charrettes this month to present key design features and solicit feedback from area residents.

The partners expect to transform the North Fifth Avenue building into an affordable independent living development for seniors.

The first charrette will begin at 7 p.m. Thursday, Nov. 7, at Relix Variety Theater, 1208 North Central Street. The second begins at 5:30 p.m. Thursday, Nov. 14, in the fellowship hall of Central United Methodist Church, 201 East Third Avenue. (A charrette is defined as an intense effort to solve an architectural or design problem within a limited time.)

The development team along with lead architect Daniel Levy of DKLevy Designs will be on hand to discuss details of the proposal, answer questions and gather input.

Southeastern Housing, an affiliate of the nonprofit Knoxville Leadership Foundation, is providing the financing for the project and will also have an ownership stake. Family Pride will

operate the facility. Family Pride is the same for-profit entity that has restored Oakwood School in the Oakwood/Lincoln Park neighborhood for assisted living for seniors.

Knox County Commission still has to approve the sale of the property, for which Southeastern and Family Pride offered \$500,000. 6. Downtown Summit to Air Development Progress, Challenges

The City of Knoxville has scheduled a "Downtown Summit" to highlight redevelopment projects in downtown Knoxville over the past decade and to hear from a panel of developers about their experiences developing downtown properties.

The summit --- to be held 5:30 p.m.-7:30 p.m. Tuesday, Nov. 19, at the East Tennessee History Center, 601 S. Gay Street --- will also provide lots of opportunity for public questions, comments and discussion.
