1. Fountain City, South Woodlawn See Leadership Changes

Fountain City Town Hall and South Woodlawn Neighborhood Association recently elected new officers and board members.

Daniel Dunn replaces Ken Cloninger as chair of Fountain City Town Hall. Jamie Rowe takes over as vice-chair from Tyler Pavlis, and Carlene Malone replaces Beth Sanderbeck as secretary. Charlotte Davis continues as treasurer. Dunn remains coordinator of Harrill Hills Neighborhood Watch.

In South Knoxville, Janice Tocher ended a five-year run as president of South Woodlawn Neighborhood Association. Her successor is Shelley Conklin.

Also elected were Danny Gray, vice-president; Debbie Sharp, secretary; Rosie Collins, treasurer; district board members Sara Baskin and Roe Lyle; and at-large representatives Betty Spangler and Janice Tocher. It is also anticipated that Dara Hinton will join the board.

"It has been my honor to serve as president for the past 5 years," Tocher said in a message to the SWNA members. "I have enjoyed watching our association grow with new membership and new ideas for how we want to continue to improve our community. I appreciate Shelley's willingness to step into this role and look forward to continued growth under her leadership."

She also thanked outgoing board members Marcia O'Neal and Kat Weaverling.

The City of Knoxville's Office of Neighborhoods, in coordination with various city departments, is conducting a four-session workshop focused on the challenges we face with blighted properties and how to better work together to address them.

The workshops will be held on four consecutive Thursday evenings, starting April 24 and ending May 15, at the CAC/L.T. Ross Building, 2247 Western Avenue. Doors will open at 5:30 p.m. The sessions will begin promptly at 6:00 p.m. and end at 7:30 p.m.

Seating is limited. Also, the Office of Neighborhoods may limit the number of participants per neighborhood or neighborhood organization. The ideal participant is someone who is a member of an established or emerging neighborhood organization that is seeking to address blighted properties on a systematic basis.

Applications must be received no later than 4:30 p.m. Friday, April 4.

At the workshop, neighborhood group representatives will learn how and why properties become blighted, examine the nuts and bolts of city code enforcement, and hear about public and private efforts that address blight. They will share views and concerns about blight and the city's response, and propose solutions for these properties at the neighborhood level as well as in collaborative efforts with the city.

Neighborhood representatives who participate in this workshop will then be eligible to participate in ongoing meetings with other participating neighborhoods and with city officials to discuss individual problem properties and possible solutions.

The Office of Neighborhoods expects that this series of workshops will be offered annually.

3. Mayor Rogero Appoints Six to Neighborhood Advisory Council

Mayor Rogero has appointed six neighborhood leaders to the Neighborhood Advisory Council, which provides advice and feedback to the city on neighborhood-related issues and concerns.

4. MPC Meeting to Explore Group Living Facilities

At the request of Knoxville City Council, the Metropolitan Planning Commission (MPC) next month will make recommendations on possible amendments to the city's zoning ordinance to better manage a wide range of group living facilities --- ranging from assisted living to overnight shelters for the homeless --- in residential areas and along commercial corridors.

Staff from MPC will host a meeting this coming Monday, March 31, starting at 5:30 p.m. in the Small Assembly Room of the City County Building, on this subject. They will outline the current status of group living facilities in the zoning ordinance, report on the ways in which other communities are changing their regulations to address group living facilities, and discuss how Knoxville can amend its ordinance to better manage this type of living arrangement. Questions and public comment will follow.

Also on the MPC preliminary agenda for April 10:

** Amendments to the city's sign regulations --- reflecting the work of a task force chaired by City Council members Duane Grieve and George Wallace over a two-year period.

** Amendments to the city zoning ordinance regarding definitions, appropriate zone districts and development standards for day care facilities.

** Owner H.E. Christenberry's request to rezone 3222 Kingston Pike from R-1 (low density residential) to RP-1 (planned residential) on a 4.8-acre site between Calvary Baptist Church and First Methodist Church. The developer would build 28 dwelling units on the site. Prior to MPC's March meeting, when this item was postponed, the Kingston Pike Sequoyah Hills Association, the Sequoyah Hills Preservation Society and Bearden Council all had opposed the RP-1 zoning, expressing concern for the historic home on the site and traffic safety hazards resulting from increased traffic on that part of Kingston Pike. MPC staff recommends approval with one condition.

** Rezoning --- from medium density residential to a C-6 general commercial park --- of a tract of land sandwiched between two residential streets off Central Avenue Pike, Elyria Drive and Dalton Place Way (Dalton Place Condos).

** AT&T Wireless's request for a use-on-review for a cell phone tower on the west side of Beaman Lake Road and south side of Sunset Avenue near Skyline Park.

** Various other rezonings and uses on review affecting a number of neighborhoods, including Oakwood Lincoln Park and Fort Sanders. To see the preliminary agenda, and then the full agenda when posted Friday afternoon, April 4, visit http://agenda.knoxmpc.org/index.htm.

5. Police, Attorney General Close Two Nuisance Nightclubs

The Knoxville Police Department and the District Attorney General's Office this week closed two nightclubs that had long been a problem for neighbors and business owners in Bearden.

Under the state nuisance law, Criminal Court Judge Bob McGee ordered the closure of La Rumba Restaurant and Bar, 4900 Chambliss Avenue, and Millennium Night Club and Bar, 315 South Mohican Street. His temporary injunction and restraining order relied on KPD's years-long investigation into "increasingly violent behavior occurring in and around the nightclubs," the AG's office said.

Since April 2008, La Rumba has been the scene of 471 calls for service to the E-911 Center, including noise complaints from residents of the Forest Heights neighborhood.

The Forest Heights Homeowners Association several years ago worked with those residents to provide evidence in court regarding violations of the noise ordinance. Efforts by the residents and the organization to meet with La Rumba's owners included .mediation supervised by the Knoxville Mediation Center.

However, while the 911 calls "initially focused around noise complaints and disturbances," the petition alleges that over time the incidents "escalated to fights, drunkenness, stabbings and shootings... At least two people have been shot at La Rumba while it was open and numerous people have reported being seriously injured in aggravated assaults while at the club."

"La Rumba is a business that thrives on allowing and encouraging illegal drug use, alcohol violations, drunkenness, quarrelling, breaches of the peace, and violent activity to take place," the petition argues. "It is a location where multiple fights, stabbings and shootings have taken place in just over the last year, placing the entire community in danger because of the activity the owners allow to occur and promote at the business."

The petition also points out that Forest Heights Homeowners Association sent a letter to Attorney General Randy Nichols on September 20, 2011, asking for help with the ongoing problems with La Rumba and the noise it generated.

The AG's petition and the court order were aimed not only at La Rumba owners Emidio Ramirez and Mauda Ponce, but also named the owner of the building, Janice R. Stooksbury of Andersonville, Tenn. Similar petitions and court orders were filed against Millennium's owner, Carlos Ponce, and the building's owner, Simpson Operating Company.

La Rumba and Millennium respondents must appear in court at 9 a.m. Thursday, April 3, to show cause why a permanent injunction should not be issued.

These nuisance injunctions mark the 41st and 42nd closures by the AG and KPD "in their ongoing collaboration to make neighborhoods safer from activities that affect the safety and quality of life of residents of this community," according to a press release issued by Nichols.

6. Grow Sunflowers for Labor Day 2014

The Labor Day Sunflower Project is seeking gardeners to help grow sunflowers this summer and to participate in the sunflower art project on Labor Day, September 1, 2014.

Labor Day Sunflower began in 2007 as a local neighborhood art installation and has grown to become an annual Knoxville multimedia, participatory arts celebration of work.

Neighborhood residents this year once again will harvest their sunflowers, gather at the installation site (Krutch Park extension in downtown Knoxville) and weave their sunflowers into a giant sunflower on a 15x15 foot frame with chain link mesh. This gathering will be followed by a week-long series of events, including video projection, music and performances. On September 8, the sunflower seeds will be collected and then distributed to the public the following spring to complete the cycle.

Each sunflower represents the harvest of individual efforts over the past year, while the circle of sunflowers represents the sum of all community efforts.

The number of participants has increased steadily over the years to include an expanding community of individuals, organizations, schools and businesses --- and they want you to join them!

The project, which is associated with the Birdhouse Community Center in the Fourth & Gill Neighborhood, invites individuals, community gardens, public gardens, schools and businesses to grow sunflowers in 2014.
