1. City Invites Comments on Annual Action Plan

The City of Knoxville is asking for public comment on the 2014-2015 Annual Action Plan, and a public meeting is scheduled for next week.

The Plan --- which is available online at www.cityofknoxville.org/development --- outlines the proposed use of Community Development Block Grant (CDBG) and HOME Investment Partnership Act funds during the fiscal year that begins July 1, 2014.

A public hearing on the Plan will be held at 5:30 p.m. Tuesday, April 8, 2014, at the Cansler YMCA, 616 Jessamine Street. Citizens may also submit their comments via e-mail to Linda Rust at lrust@cityofknoxville.org ; by mail to Linda Rust, City of Knoxville, Community Development Department, P.O. Box 1631, Knoxville, TN 37901; or by fax to 865-215-2962. Call 865-215-2120 for additional information.

All comments must be received no later than April 25, 2014. The final version of the plan is due to the U.S. Department of Housing and Urban Development on or before May 15, 2014.

2. Coming Up: First Look at Magnolia Avenue Streetscape Designs

The City of Knoxville is ready to show some schematic designs for the Magnolia Avenue Streetscapes Project, which aims to make the Magnolia corridor friendlier not only to pedestrians and bicyclists but also to economic investment and redevelopment.

A public meeting to get public feedback on these designs will be held at 5:30 p.m. Wednesday, April 16, at John T. O' Conner Senior Center, 611 Winona Street.

Kimley-Horn and Associates --- the City's professional engineering design consultant for this project --- will discuss short-term and long-term improvements to Magnolia Avenue. The firm has identified three particular areas or "nodes" along the corridor for streetscape improvements, and these will be discussed.

Because funds are not available for redesigning all of Magnolia Avenue at once, one of the nodes --- the four-block section from Jessamine Street to North Bertrand Street --- has been identified as a "model block" for near-term streetscape improvements. The designs presented on April 16 will focus on this section. Renderings will be on display and available for viewing. This meeting will solicit public comment and input.

The streetscapes project stems from recommendations outlined in Metropolitan Planning Commission's [2009 Magnolia Avenue Corridor Plan](#).

4. Combat Sprawl with Residential Density, Report Suggests

A report on sprawl development released this week by the national nonprofit group Smart Growth America has both bad and good news for the Knoxville metropolitan statistical area (MSA).

The bad news is that the MSA --- which in the report includes Knox, Blount, Anderson, Union and Loudon counties --- ranks among the most sprawling in the United States. Of

221 MSAs with populations over 200,000, ranked from least sprawl to most, the Knoxville area ranked 199.

Other Tennessee metro areas fared about the same: Memphis ranked 196, Chattanooga 207, Kingsport 212, Nashville 217 and Clarksville 219.

The good news is that many of the anti-sprawl strategies suggested in the report are already being implemented in the City of Knoxville. The report --- "Measuring Sprawl 2014" --- is available at smartgrowthamerica.org.

"This report tells us that in our major Tennessee metro areas, population density is low, people tend to live a long way from where they work, they tend to drive everywhere, and they often don't have good transportation or affordable housing alternatives available," said Mayor Madeline Rogero, who is a member of the Local Leaders Council of Smart Growth America.

The report cites studies that link sprawl to lower quality of life, including less economic mobility, higher combined costs for housing and transportation, higher rates of obesity and lower life expectancy. To counter sprawl, the report suggests several strategies: zoning to allow more residential density and mixed-use development; developing a comprehensive transportation plan, including mass transit, bicycle and pedestrian networks; and using tax-increment financing and other incentives to encourage redevelopment of blighted areas.

"This is why we in Knoxville have placed so much emphasis on smart growth in our own city," Mayor Rogero said. "We are focused on redeveloping our neglected urban areas from the core of the city outward, and on encouraging mixed-use development downtown and along key corridors. Our regional Transportation Planning Organization has comprehensive bicycle and transit plans, and we have increased KAT bus frequency on major routes to provide better transportation options for dependent and choice riders."

In addition, elected and community leaders from the five counties included in the MSA for the report have worked together for the last three years in a regional sustainability planning process called Plan East Tennessee, which gathered community input and sought ways to address issues of access to transportation, housing and employment.

"The recommendations from Smart Growth America are very much in line with what we have been working toward with Plan East Tennessee," said Mark Donaldson, Executive Director of the Knoxville-Knox County Metropolitan Planning Commission. "We know that our growth patterns over the last 50 or 60 years have created a lot of disconnects between where people live, work, go to school or go to the grocery store. Smart growth ideas are about building or strengthening those connections, which can give us more sustainable and economically viable communities."

The five-county Knoxville MSA used in the report is based on the 2010 Census. In 2013, federal guidelines redefined the Knoxville MSA to also include Campbell, Grainger, Morgan and Roane counties.

5. Detour Announced for Section of Third Creek Greenway

Starting Monday and lasting until early May, a section of the Third Creek Greenway will be closed to allow KUB to perform utility work. A detour route will be marked so users can continue to reach their destinations.

The closed section starts at Lebanon Street (behind the shopping center that includes Earth Fare and Ace Hardware) and runs the entire length of the new U.T. Sports Complex. The detour route utilizes the Bearden Village Greenway along Sutherland Avenue.
