2. South Woodlawn to Celebrate Habitat Certification

The South Woodlawn Neighborhood Association this weekend will celebrate the hard work and community spirit that went into the neighborhood's designation as the first “Certified Community Wildlife Habitat” in Tennessee.

The celebration event will be from 1-3 p.m. Saturday, April 12, at Stanley's Greenhouse, 3029 Davenport Road, and will include refreshments, live music, information booths, and speakers from the National Wildlife Federation. Other neighborhoods are invited to attend so they can learn how to achieve this NWF designation.

4. Coming Up: First Look at Magnolia Avenue Streetscape Designs

The City of Knoxville is ready to show some schematic designs for the Magnolia Avenue Streetscapes Project, which aims to make the Magnolia corridor friendlier not only to pedestrians and bicyclists but also to economic investment and redevelopment.

A public meeting on these designs will be held at 5:30 p.m. Wednesday, April 16, at John T. O'Connor Senior Center, 611 Winona Street.

Kimley-Horn and Associates --- the City's professional engineering design consultant for this project --- will discuss short-term and long-term improvements to Magnolia Avenue. The firm has identified three particular areas or "nodes" along the corridor for streetscape improvements.

Because funds are not available for redesigning all of Magnolia Avenue at once, one of the nodes --- the four-block section from Jessamine Street to North Bertrand Street --- has been identified as a "model block" for near-term streetscape improvements. The designs presented on April 16 will focus on this section. Renderings will be on display. This meeting will solicit public comment and input.

The streetscapes project stems from recommendations outlined in Metropolitan Planning Commission's [2009 Magnolia Avenue Corridor Plan](#).

5. Take a Stand Against Bullying

6. "Green the Block" Headed for Mechanicsville

"Green the Block" --- a day of community service and action --- is planned for the Mechanicsville community from noon to 4 p.m. on Saturday, April 19.

The sponsor --- a community-based organization called SEED (Socially Equal Energy Efficient Development) --- says the main purpose of the event is to demonstrate how green jobs can be created to address low employment rates among young adults, reduce energy costs, and reduce homelessness (which can often be caused by high energy bills).

Two teams of volunteers will be deployed starting at noon from Danny Mayfield Park, 700 College Street. One group will conduct a house-to-house survey of residents' energy consumption and weatherization needs. The other group will be engaged in a traditional

The survey and cleanup will conclude with a 3 p.m. rally in Danny Mayfield Park. There will be food, music, and family entertainment provided by First Baptist Church of Concord.

7. Free Water! Order Your Rain Barrel Now

Here's a way to do your part to prevent flash flooding while conserving water and lowering your utility bill.

Order a 50-gallon rain barrel that captures rainwater from your roof --- water you can then use to water your garden or wash your car.

Manufactured by Rain Water Solutions in North Carolina, the "Ivy" rain barrel is available for a discounted price of \$70 and is made of 50 percent recycled plastic. The barrel is green but can be decorated with acrylic paint and then sealed. The barrel comes with installation instructions and needed parts.

The City of Knoxville Office of Solid Waste is partnering with the Town of Farragut, Knox County Storm Water Management Department and the Water Quality Forum to offer the discounted rain barrels, which typically retail for \$129.

Residents are encouraged to pre-order and then pick up their rain barrels between 10 a.m. and 3 p.m. on Saturday, April 26, at the Blackstock Avenue parking lot near that day's Earth Fest events on World's Fair Park.

"We are committed to protecting our water quality and managing the damaging effects of storm water runoff," observed Parci Gibson of Water Quality Forum. "The use of rain barrels will provide residents the tools they need to be environmentally proactive."

9. MPC Okays Multi-Unit Development on Kingston Pike

The Metropolitan Planning Commission this week overwhelmingly approved the controversial rezoning of 3222 Kingston Pike from R-1 (single family residential) to RP-1 (planned residential) --- despite the strenuous objections of the Kingston Pike Sequoyah Hills Association (KPSHA) and neighborhood residents.

The 4.8-acre parcel, located between Calvary Baptist Church and First Methodist Church, could support about 25 condo units under the recommendation that MPC made to City Council.

KPSHA cited auto accident statistics to support its belief that the hundreds of additional trips per day generated by such a development would further complicate an already dangerous curve on the Pike. The group also maintained that the multi-story development would negatively impact the single-family character of the neighborhood.

But MPC commissioners were persuaded by the developer's promises to save the historic house on the site and to work with City Engineering to develop ingress and egress points that would meet Engineering's sight distance and safety requirements. Through its attorney, the developer also asserted that the condo structures would be invisible from the Pike, but apparently that claim is based on siting the buildings closer to the slope over the Tennessee River. MPC staff had argued that fewer units per acre were necessary to observe strict new requirements for developing slopes.

Following the meeting, KPSHA representatives vowed to continue its opposition as the matter heads to City Council. Other groups, including Bearden Council and the Sequoyah Hills Preservation Society, had also opposed the rezoning.

In other actions, MPC:

** Postponed until May its consideration of major changes to the city's sign ordinance, providing time for the Sign Task Force to reconvene to consider changes.

** Postponed until June a proposed new ordinance setting out new definitions, zone districts and development standards for group living facilities.

** Postponed until June consideration of amendments to the zoning ordinance regarding appropriate siting of day care facilities in residential neighborhoods. MPC Executive Director Mark Donaldson said the proposals will be floated in front of a number of neighborhood groups in the meantime.
