2. Garbage and Curbside Recycling: Normal Schedule Next Week

Waste Connections, the city's household garbage and recycling collector, will run its normal schedule for the collection for residential garbage and curbside recycling all of next week, including Memorial Day, Monday, May 26.

Downtown trash collection will also run on normal schedule. The city's recycling centers will be open per usual on Monday, but the Goodwill attendant will not be available to accept household goods donations or to assist with recycling.

The City's Solid Waste Management Facility located at 1033 Elm Street will be closed the entire three-day weekend in observance of the holiday.

3. Honor Fountain City Day to Feature Neighborhoods

Knoxville Mayor Madeline Rogero is the keynote speaker for this year's "Honor Fountain City Day," sponsored by Fountain City Town Hall (<u>www.fountaincitytownhall.org</u>).

The annual event in Fountain City Park --- dating from 1975 --- attracts hundreds of people, families, community leaders, elected officials and candidates for a full day of music, food, speeches, community awards, and recognition of the service and sacrifice of the nation's military veterans.

Entertainment begins at the Gazebo at 10:30 a.m. Monday, May 26, with the band Nostalgia and at the Covered Pavilion at 11:30 a.m. with the New Beverly Twirlers. Other entertainment includes David Correll's Band, the East Tennessee Concert Band, Tricky Nicky the Magician, the ZooMobile from the Knoxville Zoo, and other activities for children.

The Community Awards Ceremony begins at 3 p.m. with Mayor Rogero delivering the keynote speech followed by the presentation of the community awards --- Friend of Fountain City, Chairman's Award, renovation/beautification awards, Woman of the Year, and Man of the Year.

The Memorial Day Ceremony, beginning at 4 p.m., will feature remarks by WBIR Anchor John Becker and U.S. Congressman John J. Duncan, Jr.; music by Lynn Bennett; and the East Tennessee Veterans Honor Guard

4. Citizens Can Testify on Blighted Properties

Here are the properties on the agenda for the next Public Officer Hearing at 9:30 a.m. Friday, May 30, in the Small Assembly Room of the City County Building.

The properties that have been approved to be heard for repair/demolition orders are: 1610 Clinch Avenue, 113 Drinnen Avenue, 905 Drive D, 132 South Elmwood Street, 201 Fern Street (accessory structure only), 2811 East Fifth Avenue (accessory structure only), 4530 Holston Drive (trailers #1, #4, #7, #12, #14, & #16), 6208 King Road, 1802 Minnis Avenue, 4606 Prospect Road, 5313 Rowan Road, 2328 Southside Street, 810 & 814 State Street (confirmation of emergency repair only order), 5807 East Sunset Road, 5129 Tenwood Drive, 1912 Victoria Avenue, 1825 Woodbine Avenue, and 2861 Woodbine Avenue (accessory structure only).

Properties on the agenda for boarding confirmation are: 3614 West Blount Avenue, 1214 Callaway Street, 1111 Henrietta Drive, 438 Hiawassee Avenue, 2301 Riverside Drive, 1912 Victoria Avenue, and 1825 Woodbine Avenue. These are vacant buildings that were secured and boarded by the city because they were accessible and an attractive nuisance.

At this meeting, the Public Officer --- David Brace, director of the Public Service Department --- will hear testimony on buildings that inspectors contend are in violation of the city's building codes. Testimony can also be made by the property owners, neighbors, neighborhood groups, and other stakeholders, such as lien holders.

The Public Officer then decides whether to issue an order requiring that the violations be addressed in a certain period of time. Failure by the owner to cure the problem may result in the boarding or demolition of a structure, or the cleanup of a dirty or overgrown lot, with costs billed to the owner. A property owner may appeal the Public Officer's decision to the Better Building Board and, ultimately, to Chancery Court.

If any of these properties are in your neighborhood, consider attending the meeting to submit testimony about the impact of the property on the neighborhood.

6. Advisory Council to Ponder Residential Occupancy Standards

Within its Zoning Code, the City of Knoxville has certain standards and definitions that govern the occupancy of residential dwelling units.

The City of Knoxville Code of Ordinances, at Appendix B, Article V, Section 21, addresses residential occupancy standards. Families --- heads of household plus persons related to them by blood, marriage, adoption and guardianship, including foster children --- can of course, occupy a dwelling unit. A "functional family" can also occupy all types of dwelling units. A functional family can consist of up to five unrelated individuals who are living as a household and who meet certain criteria set forth in Appendix B, Article V, Section 22.

The Neighborhood Advisory Council will delve into residential occupancy standards and the City's provisions on functional family when it meets at 4:30 p.m. Wednesday, June 11, at the CAC/L.T. Ross Building, 4107 Western Avenue. Crista Cuccaro, an attorney in the City's Law Department, will make a presentation and take questions. The meeting is open to the public.

8. Give Your Views on Bicycle Facilities Plan

If you weren't one of the 50 people that attended Wednesday night's public meeting on the City of Knoxville's Bicycle Facilities Plan, you still have an opportunity to share your views and ideas.

The City's professional design consultants --- Kimley-Horn and Associates Inc. and Toole Design Group --- are developing the plan, which will determine a 50-mile city-wide bikeway network focused on improving the accessibility, safety and convenience of traveling by bicycle.

Within those 50 miles of planned bikeways, the consultants will make recommendations for 20 high- priority, short-term projects that address barriers to cycling and/or improve important connections in the bikeway network. These projects will include both on-road and off-road facilities.
