## 1. City Seeks Input on Five-Year Community Development Plan

What are the top three needs in your neighborhood? What are your needs as a renter? A homeowner?

These are just some of the questions that the city's Community Development Department is asking in a broad investigation of community needs. There are two ways that neighborhood residents and leaders may provide their input:

\*\*\* Participate in a public meeting on Tuesday, Oct. 21, starting at 5:30 p.m., at the John T. O'Connor Senior Center, 611 Winona Street.

This survey of community needs is a critical part of the City's Consolidated Plan, which guides and sets priorities for the use of federal funds from Community Development Block Grants (CDBG), HOME Investment and other programs that are generally directed at low- to moderate-income groups and individuals. The Community Development Department is now in the process of updating the Consolidated Plan.

"This is a great opportunity for us to reach out across the city and ask people to tell us the greatest needs and challenges they see in their communities," said Becky Wade, the City's Director of Community Development. "We have limited resources, and so we want to make sure we are directing them to the places where they will do the most good."

Community Development staff also is conducting focus groups with organizations and agencies working in affordable housing, senior services, health care and youth issues. There will also be efforts to reach out to a range of disadvantaged and minority communities.

## 2. KEMA Offers Community Emergency Response Team Training

The Knoxville-Knox County Emergency Management Agency (KEMA) --- in cooperation with other local emergency response agencies --- is offering Community Emergency Response Team (CERT) training.

Neighborhood representatives are urged to sign up.

"During major emergencies and disasters, emergency response agencies can be overloaded, and professional responders may not be immediately available," says KEMA Operations Officer Colin Ickes. "The CERT program gives people the information and skills they need to be prepared and to be able to help themselves, their households and their neighbors during a disaster."

When individuals complete CERT training, they are expected to focus on their neighborhoods and their immediate area. "When [CERT members] see a need in their neighborhood, and they can put their CERT skills into practice, then they should do so," Ickes explained.

The CERT class will meet a total of eight times. Seven sessions will be held at 6 p.m. Thursdays, starting Oct. 16 and ending December 4 (skipping Thanksgiving). The last class will take place on Saturday, Dec. 6.

Each class session will last approximately 2.5 to 3 hours. There is no cost for the course, and all materials will be provided.

The first class on October 16 will be at the Knox County 911 Center at 605 Bernard Avenue. Other classes will take place at the facilities of local emergency response agencies in Knox County.

## 3. Mayor, City Council Urge Approval of Pension Amendments

Mayor Madeline Rogero and the nine members of Knoxville City Council are urging city voters to approve five amendments to the Knoxville City Charter that are on the ballot in this fall's election.

To assist voters, the city has compiled a summary of the five amendments. This summary --- located at <a href="http://www.cityofknoxville.org/pension/">http://www.cityofknoxville.org/pension/</a> --- includes the actual ballot language for each amendment (confusing but legally required), a simple description of what the

amendment would do, and an explanation of why Mayor Rogero and City Council support each amendment.

Mayor Rogero is urging city voters to go through the entire ballot, because the City Charter amendments are at the very end of the ballot.

Also on this year's ballot are state and federal general elections, four state Constitutional amendments, the election to fill the District 2 vacancy on the Knox County School Board, and a referendum on whether to allow the sale of wine in retail food stores.

Early voting runs from Wednesday, October 15, through Thursday, October 30, and Election Day is Tuesday, November 4. ### 4. Consider Serving on the Neighborhood Advisory Council

The City of Knoxville is seeking to fill two vacancies on the 15-member Neighborhood Advisory Council (NAC).

Appointed by Mayor Madeline Rogero, the NAC provides insight and advice to the city administration on a wide variety of neighborhood-related issues. These include neighborhood projects, blight, sidewalks, zoning, commercial development, and the various programs and policies of the Office of Neighborhoods.

NAC is composed of two neighborhood leaders from each of the six City Council districts and three at-large members. Appointees to the district seats must live in that particular City Council district, whereas appointees to the at-large seats can live anywhere in the city. Each member can serve one full 3-year term, followed by a second full 3-year term, except that a member has to apply for reappointment.

The two vacancies on the NAC are Seats 1-A and 6-A. Candidates for Seat 1-A must live in the first City Council District, which is comprised of Fort Sanders and all of South Knoxville. Candidates for Seat 6-A must live in the sixth City Council district, which includes most of East Knoxville, downtown, Mechanicsville, Beaumont and a portion of the Sutherland Avenue area. ### 5. MPC Postpones Sign Ordinance, Schedules Workshop

The Metropolitan Planning Commission this week decided to delay a vote on the proposed new sign ordinance in favor of holding a second workshop on the subject.

The workshop will focus on the differences between the sign ordinance as forwarded to the commission by a special Sign Ordinance Task Force and a version proposed by MPC Director Mark Donaldson. Commissioners Thursday expressed a desire to see the differences more clearly delineated.

The workshop is scheduled for 4:30 p.m. Thursday, October 30, in Room 453 of the City County Building. The meeting is open to the public. The ordinance will be back on the MPC agenda in November. If adopted then as a recommendation to City Council, the ordinance would reappear on City Council's agenda in December.

It was three years ago this fall that a previous Knoxville City Council voted to lower the height of signs in the city. That change was passed only on first reading and therefore did not become law. Later, a <u>Sign Ordinance Task Force</u> was appointed to delve into the issue, and it was then decided that a wholesale updating of the ordinance should be undertaken.

Chaired by City Council Member Duane Grieve, with City Councilman George Wallace serving as vice chair, the task force met several times over a two-year period and held two public meetings to hear citizen comment. During that time, the task force reached a compromise that lowered the height of pole signs from 50 feet to 40 feet near Interstate interchanges and 30 feet everywhere else.

MPC staff is suggesting alternative criteria tied to the type of street that a business is located on.

The nonprofit advocacy group <u>Scenic Knoxville</u> has advocated much more stringent limits --- to just 25 feet for pole signs near Interstate interchanges, for example. Also this week, 11 of the current 13 members of the Neighborhood Advisory Council voted to support the Scenic Knoxville limits. Two members abstained, citing a need for more information.

# 6. City Makes Short-Term Construction Loans for Blighted Properties

The City of Knoxville's Community Development Department is accepting applications for the Blighted Property Redevelopment Program (BPRP).

The BPRP provides short-term development and construction financing through subsidized loans for the purpose of redeveloping and renovating unoccupied, eligible residential dwelling units or construction of new dwelling units on eligible, vacant properties.

Following renovation, the property may be rented, put up for sale or occupied by the loan recipient. The total amount of funding available at this time is \$155,000.

The website is part of the bicycle program sponsored by the Knoxville Regional Planning Organization, also known as TPO. As noted on the new site:

- \*\*\* TPO is seeking a part time intern to work 10 hours per week for \$15 per hour as a contract vendor. The intern will help educate folks about being safe around bicyclists. The deadline to apply is October 24.
- \*\*\* The date for this year's Tour de Lights --- a tour of downtown and nearby neighborhoods on decorated bikes --- is Friday, December 19.
- \*\*\* Knoxville has bike rentals available at the Outdoor Adventure Center (Volunteer Landing) and the Knoxville Visitors Center (corner of Summit Hill & Gay). You can also secure a reservation online. Two-hour bike rentals cost \$19 for adults, \$15 for teachers and military personnel, and \$12 for youth under 17. Friends of Legacy Parks receive a 50% discount. Rentals include the bike, a lock, and a map.
