1. City Council Candidates on Stage Tonight

A moderated forum with this year's candidates for Knoxville City Council will be held at 7 p.m. today --- Tuesday, Sept. 8 --- at the Clinton Chapel AME Zion Church, 546 College Street, Knoxville, TN 37921.

Early voting begins Wednesday and ends Sept. 24. The primary will be held on Sept. 29 and the general election on Nov. 3.

The forum is co-sponsored by the <u>League of Women Voters of Knoxville/Knox County</u>, the National Association for the Advancement of Colored People (NAACP) and the Knoxville Interdenominational Christian Ministerial Alliance (KICMA).

John Becker, News Anchor at WBIR-TV, will moderate. Following the forum, the public is invited to meet the candidates from 8:00 to 8:30 p.m. A Voter's Guide, with questions answered by City Council candidates, will be available.

2. Memorial Service to Honor Victims of 9/11 Attacks

The City of Knoxville and Knox County will hold a joint 9/11 Memorial Service to honor those who lost their lives during the terrorist attacks on Sept. 11, 2001.

The observance will be held at 8:40 a.m. Friday, Sept. 11, at the 9/11 Memorial in front of the City County Building, 400 Main Street. The ceremony will be led by the Knox County Sheriff's Office, the Knoxville Police Department and the Knoxville Fire Department.

3. CAC Office on Aging Sponsors Disaster Preparedness Fair

The CAC Office on Aging is sponsoring a disaster preparedness fair from 9 a.m. until 1 p.m. this Friday, Sept. 11, at the O'Connor Senior Center, 611 Winona Street.

This event --- named the "Serve, Honor, Learn: Disaster Preparedness Summit for Seniors" --- is a tribute to the 9/11 National Day of Service.

The fair will include panel discussions on disaster preparedness for seniors (9:45 a.m. until 11 a.m.) and for children (11:45 a.m. to 1 p.m.). Before the first panel and in between the two panels, booths will be available for people to learn more about preparedness from various groups.

4. City to Dedicate Work at Mary Vestal, West Hills

The City of Knoxville will dedicate new installations at parks in South Knoxville and West Knoxville over the next few days.

Mayor Madeline Rogero, Vice Mayor Nick Pavlis and other City Council members will join community members at 5 p.m. Wednesday, Sept. 9, to unveil new public art at Mary Vestal Park, 401 Maryville Pike in South Knoxville.

Entitled "No Place Like Home," the artwork was created by Alan Finch and Joe Babb in 2003 for the Tennessee One Ton Show, and the sculpture was later donated by Candoro Properties to the City at the initiative of David Witherspoon, president of Candoro Properties.

Mary Vestal Park is designed around the scenic Goose Creek in South Knoxville. Mary Vestal Greenway follows the creek throughout the park. South Knoxville Community Center is located across the street from the park.

Then at 10 a.m. Monday, Sept. 14, the City will dedicate the new pickle ball court in West Hills Park and also recognize the new "tiny free library" that was established on the Jean Teague Greenway by Anne Crais of Wesley Neighbors, a neighborhood organization on the eastern edge of West Hills. Both the court and the tiny free library are located on the Sheffield Drive side of the park.

5. Property Tax Sale Next Week

The City of Knoxville will conduct a sale of tax-delinquent properties starting at 10 a.m. next Tuesday, September 15, in the Large Assembly Room of the City County Building.

8. National Night Out Set for Tuesday, October 6

It is not too early to begin making plans for National Night Out, which the City of Knoxville will observe on Tuesday, October 6.

During National Night Out, neighborhood groups host potluck suppers, picnics, and other events to celebrate the strength of community and send a message to would-be

thieves and con artists that neighbors keep an eye out for them and watch out for one another.

This is a nationwide effort promoted by the National Association of Town Watch (<u>www.natw.org</u>), which suggests that the event be held either the first Tuesday of August or the first Tuesday of October. Due to the likelihood of thunderstorms and hot temperatures in August, the Knoxville Police Department observes the event in October each year.

This will ensure that KPD schedules officers to attend your event. Be sure to give the name and phone number of your contact person and organization, the time your event will begin and end, and the exact location.

9. Arts and Fine Crafts Center Seeks Ideas for Classes

One of the best kept secrets in town is the Knoxville Arts and Fine Crafts Center (KAFCC) located at 1127 North Broadway.

The Center offers a wide variety of classes ranging from pottery and jewelry making to belly dancing, French lessons and culinary arts. But the Center's new interim director, Elise Murphy, is eager to hear if you or members of your organization are interested in a class the Center is not now offering.

KAFCC is a program of the City of Knoxville's Parks and Recreation Department. Fees are charged because classes are taught by contracted staff.

Look through the list of youth, adult, fitness and food classes. If you do not see what you are looking for, contact KAFCC with your suggestions for classes aimed at any age or group. For example, if your daughter wants to learn how to Double Dutch (jump rope), or your grandfather is interested in Stained Glass Art, you simply have to request a class. If the Center gets several requests for the same thing, they will work to get a class started.

10. BZA Decisions Can Impact Your Neighborhood

Twelve properties on the agenda for next week's meeting of the Board of Zoning Appeals (BZA).

Established by city ordinance, BZA hears appeals of denials of building permits by the city's Building Inspections Department. The board, consisting of five citizens appointed

by the Mayor, meets at 4 p.m. on the third Thursday of each month in the Small Assembly Room of the City County Building.

BZA meets next Thursday, September 17. Addresses on the agenda include 317 Ogden Street, 708 Washburn Road, 1208 Kenyon Street, 104 N. Seven Oaks Drive, 9320 Kingston Pike, 937 N. Broadway, 5517 Ball Camp Pike, 4505 Asheville Hwy, 3701 Sevierville Pike, 4700 Treybrooke Lane, 407 McConnell Street, and 1644 Ailor Avenue.

Keep up with how the BZA might impact your neighborhood. Watch for the black and white signs indicating that there is a pending decision on a particular piece of property. Most signs are for Metropolitan Planning Commission issues --- which are also important --- but signs with the word "variance" are BZA items.

The BZA agenda is posted on the city website. Browse to <u>www.knoxvilletn.gov/boards</u> and click on Board of Zoning Appeals. The agenda is posted no later than the Monday prior to the BZA meeting each month.

A neighborhood group that keeps track of BZA will call the Plans Review & Inspections Department at 215-3669 to request and study the paperwork on a particular appeal, decide whether to take a position on the appeal, and then attend the BZA meeting to voice the group's support or objections.

Decisions of the BZA can be appealed within 15 days of the BZA decision to Knoxville City Council. Appeals of a City Council decision are made to Chancery Court within 60 days of a City Council decision related to BZA.

11. City Seeks Comment on Annual Performance Report

A draft of the City of Knoxville's Consolidated Annual Performance and Evaluation Report (CAPER) will be available for citizen review and comment for a period of 15 days beginning today, Sept. 8, 2015.

The report describes how the City of Knoxville spent Community Development Block Grant, HOME Investment Partnerships Act, and Emergency Solutions Grant funding received from the U.S. Department of Housing and Urban Development during the fiscal year that ended June 30, 2015.
