1. Fourth & Gill to Host Community Meeting on Pain Clinic

The Fourth & Gill Neighborhood Association will hold a North Knoxville community meeting at 7 p.m. Thursday, Jan. 7, at Central United Methodist Church, 201 E. Third Avenue, to discuss a new pain clinic planned for the former UNITE labor union building at 1124 N. Broadway.

"The clinic will provide treatment for spine and neck pain and will provide medically assisted treatment for opioid addiction," according to a notice issued by the neighborhood organization. "The clinic will be run by Dr. (Michael) Chavin, who currently operates a similar clinic in Morristown. Dr. Chavin recently moved to Knoxville and will close his Morristown clinic to work exclusively at his new Knoxville clinic.

"To provide the North Knoxville community with a better understanding of his clinic and his services, Dr. Chavin recently reached out to Fourth & Gill President Liz Upchurch asking to schedule a community meeting.

"The meeting will provide an opportunity to hear Dr. Chavin describe his practice and the patients he serves, and we will have a Q&A session following his presentation," the notice concludes.

2. What is the State of Your Neighborhood? The City Wants to Know

Getting input from city residents about the current state of affairs in their neighborhoods is one of the goals of a public meeting to be held at 5:30 p.m. Tuesday, Jan. 12, at O'Connor Senior Center, 611 Winona St.

The purpose of the meeting is to gather information and public input as the city's Community Development Department develops its Annual Action Plan Update for the proposed use of federal funds for the program year 2016-2017.

Each year, the department utilizes Community Development Block Grant (CDBG), HOME Investment Partnership Act, and Emergency Solutions Grant (ESG) funds. All three funds are administered by the U.S. Dept. of Housing and Urban Development (HUD).

At this meeting, Community Development staff will review priorities and strategies from the 2015-2019 Five Year Consolidated Plan and constraints that impact how HUD funds are allocated; get specific feedback from neighborhood, business, and non-profit housing and homeless services partners on opportunities/challenges; and take comments from other citizens.

3. Deadline Extended for Neighborhood Achievement Awards

The deadline to submit applications and nominations for Neighborhood Achievement Awards has been extended by two weeks --- from Jan. 11 to Jan. 25.

Neighborhood Achievement Awards recognize the work of the city's neighborhood organizations in improving, protecting and enhancing their neighborhoods.

Awards will be presented at the **Neighborhood Awards and Networking Luncheon** that will be held Saturday, March 5, at the Knoxville Convention Center. The Diana Conn Neighbor of the Year Award will also be presented at the luncheon.

Neighborhood organizations are encouraged to submit an application for these competitive awards. First, if you have completed a neighborhood improvement project, engaged in community-building activities or made strides in strengthening your organization, you deserve the recognition, not only across the city but in your own neighborhood.

Secondly, these awards will encourage other neighborhoods to take on similar community-building projects. So don't be shy --- apply!

Whether your group is large or small, well established or brand new, your group is encouraged to apply. The awards will showcase accomplishments by neighborhood groups during calendar years 2014 and 2015.

4. Grant Funding Available for City Neighborhood Groups

The City of Knoxville is allocating up to \$43,000 for the Neighborhood Small Grants Program (NSGP) in 2016.

Grant funds can be used for projects and programs developed by resident-led, residentcontrolled neighborhood associations, tenant associations, homeowners associations, and neighborhood watch groups that serve neighborhoods inside city limits. Start-up neighborhood groups may also apply.

Groups wishing to apply must send a representative to either one of two mandatory preapplication workshops scheduled for 5:30 p.m. Thursday, January 14, and 5:30 p.m. Wednesday, January 20, at the Cansler Family YMCA, 616 Jessamine Street.

Applications are due March 14, and awards will be announced in May for projects starting in July.

Neighborhood groups can apply for grants ranging from \$500 to \$3,000. To enhance the impact of the city's funding, grants must be matched with donations of goods and services, volunteer labor and other financial support for the project.

The <u>grant guidelines</u> and the <u>application form</u> are available on the city's website. Also, call Debbie or David if you have questions or just wish to talk about project ideas.

Please note that many questions can be answered by reading the guidelines and looking over the application. Both the guidelines and application will be reviewed at the January workshops.

5. Advisory Council to Review Proposed Ordinance on Food Trucks

The Mayor's Neighborhood Advisory Council will meet at 4:30 p.m. Wednesday, Jan. 13, at Cansler YMCA, 616 Jessamine Street, to discuss a proposed ordinance to regulate mobile food vendors, more commonly known as food trucks.

Patricia Robledo, head of the city's Office of Business Support, and Crista Cuccaro, a member of the city law department, will attend the meeting to make a short presentation about the proposed regulations and then address questions and comments.

The City is seeking NAC's input, especially with regard to whether the ordinance as written raises concerns about impacts on residential neighborhoods, and whether NAC members have suggestions for improvements, if any are needed.

NAC meetings are open to the public. All interested persons are invited to attend.

6. Consider Serving on the Neighborhood Advisory Council

If you would like an opportunity to offer regular input and advice to Mayor Madeline Rogero and her administration about neighborhood issues in Knoxville, now's your chance.

The Mayor's <u>Neighborhood Advisory Council</u> (NAC), established in 2009, meets at 4:30 p.m. on the second Wednesday of each month to discuss Knoxville's residential neighborhoods and provide the city with candid viewpoints on how they can best be maintained, supported, improved, rejuvenated and sustained.

The NAC may offer advice to the Mayor or to any city department, either at its own initiative or at the request of a department wanting neighborhood input on a particular matter.

NAC consists of neighborhood leaders and activists who occupy a total of 15 seats --two in each of the six City Council districts and three at large. Terms are for three years, and members may serve up to two full terms (six years). Members wishing to serve a second three-year term must reapply. The terms of five of the 15 seats expire this March.

These seats, current occupants and general territory are:

- *** Seat 1-B (Terry Caruthers) South Knoxville and Fort Sanders
- *** Seat 3-A (Donna Downen) Northwest Knoxville

*** Seat 4-A (Lauren Rider) – North Knoxville east of Broadway, Cedar Lane area east of Parkdale Road, Old North Knoxville, and portions of Chilhowee Hills and Holston Hills *** Seat 5-B (Bill Hutton) – North Knoxville west of Broadway, Inskip, Lonsdale and portions of Norwood

*** At large Seat A (Amy Midis) – city-wide

In addition, Seat 5-A is vacant, and someone will be appointed to serve the remaining two years of that term.

The Office of Neighborhoods is seeking applications from neighborhood leaders who wish to serve in these seats. To be appointed to a numbered seat, you must live in that City Council district. For example, the person appointed to Seat 5-A will be a resident in the fifth City Council district.

If you would be interested in serving on the NAC, you may fill out and submit an application, which is <u>located online here</u>. Or call David Massey in the Office of Neighborhoods at 215-3232 to have a hard copy mailed to you. Call David if you wish to learn more about the position. Applications are due by Monday, Feb. 8. Mayor Rogero makes the appointments.
