1. Fourth & Gill, Birdhouse to Host "Shed Warming" Party

The <u>Fourth & Gill Neighborhood Organization</u> and the <u>Birdhouse Community Center</u> this weekend will throw what is arguably the first "shed warming" party in the history of Knoxville's neighborhoods.

The event will take place from 6-9 p.m. Friday, Jan. 22, at the Center, 800 North Fourth Street.

Fourth & Gill has been blessed with a neighborhood center at the corner of North Fourth Avenue and Gill Avenue since the early 1970s --- a donation from the late real estate developer, Gene Monday.

A few years ago, the organization decided to contract with a group of young people to operate the center, which they named "the Birdhouse." The group poured untold hours of work into repairing floors, painting and generally fixing up the Victorian era building. And they have hosted a wide variety of activities from Fourth and Gill board meetings and poetry slams to a community garden and art gallery.

But as activities and participation grew, so did the need for storage. So last year the neighborhood organization partnered with the Birdhouse to apply for a grant from the Neighborhood Small Grants Program. Half of the \$2,500 award went to the organization's ARToberfest, and half went to the construction of a storage shed behind the Center.

"Thanks to the City of Knoxville and the hard work of a host of volunteers, the Fourth and Gill neighborhood and the Birdhouse Community Center have a shed," noted Gerry Moll of the Birdhouse. "The shed is a great asset to both the neighborhood and to the Birdhouse.

"The neighborhood's collectively owned infrastructure such as signage and a pretzel warmer can be stored in this centralized, easily accessible building," Moll continued. "The Birdhouse can store tools, art supplies, outdoor chairs and lawnmowers that have been cluttering every corner of the community center for years. The project stands as a

fine example of a successful community building project and reflects a long time motto of the neighborhood --- 'Together We Are Strong."

2. Grants Workshops: One on Wednesday, Another on Jan. 30

The second pre-application workshop for the Neighborhood Small Grants Program (NSGP) will be held this week as scheduled, but due to the threat of inclement weather, the Office of Neighborhoods will hold a third workshop later this month.

City neighborhood organizations that wish to apply for funding under the Neighborhood Small Grants Program must send one or more representatives to a mandatory preapplication workshop. The first of these was held last week. The second is set for 5:30 p.m. Wednesday, Jan. 20, at the Cansler Family YMCA, 616 Jessamine Street.

Attend the Jan. 20 workshop at your own risk. If you wish to confirm that the meeting will be held, call the Office of Neighborhoods at 215-3232 any time prior to the meeting.

If you would rather wait or if you already had a conflict for Jan. 20, a third and final workshop will be held on Saturday, Jan. 30, at a still undetermined time and place. It is necessary to attend only one of the workshops, which last 60-75 minutes.

Grant applications are due March 14, and awards will be announced in May for projects starting in July. The City is allocating up to \$43,000 for the grants program this year. Neighborhood groups can apply for grants ranging from \$500 to \$3,000. To enhance the impact of the city's funding, grants must be matched with donations of goods and services, volunteer labor and other financial support for the project.

The <u>grant guidelines</u> and the <u>application form</u> are available on the city's website. Please note that many questions can be answered by reading the guidelines and looking over the application. Both the guidelines and the application will be reviewed at the workshops.

Grant funds can be used for projects and programs developed by resident-led, resident-controlled neighborhood associations, tenant associations, homeowners associations, and neighborhood watch groups that serve neighborhoods inside city limits. Start-up neighborhood groups may also apply.

3. Five More Days to Apply for Neighborhood Achievement Award

Neighborhood organizations deserve recognition for the work that they do on behalf of their community.

Neighborhood Achievement Awards recognize the work of the city's neighborhood organizations in improving, protecting and enhancing their neighborhoods.

Awards will be presented at the **Neighborhood Awards and Networking Luncheon** that will be held Saturday, March 5, at the Knoxville Convention Center. The Diana Conn Neighbor of the Year Award will also be presented at the luncheon.

Neighborhood organizations are encouraged to submit an application for these competitive awards. The deadline is next Monday, Jan. 25.

Two reasons to apply: First, if you have completed a neighborhood improvement project, engaged in community-building activities or made strides in strengthening your organization, you deserve the recognition, not only across the city but in your own neighborhood.

Second, these awards will encourage other neighborhoods to take on similar community-building projects. So don't be shy --- apply! The application form is simple and straight forward.

Whether your group is large or small, well established or brand new, your group is encouraged to apply. The awards will showcase accomplishments by neighborhood groups during calendar years 2014 and 2015.

4. City Seeks Candidates for Neighborhood Advisory Council

Applications are due by Monday, Feb. 8, for citizens interested in serving on the Mayor's Neighborhood Advisory Council (NAC).

Established in 2009, the NAC meets at 4:30 p.m. on the second Wednesday of each month to discuss Knoxville's residential neighborhoods and provide the city with candid viewpoints on how they can best be maintained, supported, improved, rejuvenated and sustained.

The NAC may offer advice to the Mayor or to any city department, either at its own initiative or at the request of a department wanting neighborhood input on a particular matter.

NAC consists of neighborhood leaders and activists who occupy a total of 15 seats --- two in each of the six City Council districts and three at large. Terms are for three years, and members may serve up to two full terms (six years). Members wishing to serve a second three-year term must reapply. The terms of five of the 15 seats expire this March.

These seats, current occupants and general territory are:

- *** Seat 1-B (Terry Caruthers) South Knoxville and Fort Sanders
- *** Seat 3-A (Donna Downen) Northwest Knoxville
- *** Seat 4-A (Lauren Rider) North Knoxville east of Broadway, Cedar Lane area east of Parkdale Road, Old North Knoxville, and portions of Chilhowee Hills and Holston Hills *** Seat 5-B (Bill Hutton) North Knoxville west of Broadway, Inskip, Lonsdale and
- *** Seat 5-B (Bill Hutton) North Knoxville west of Broadway, Inskip, Lonsdale and portions of Norwood
- *** At large Seat A (Amy Midis) city-wide

In addition, Seat 5-A is vacant, and someone will be appointed to serve the remaining two years of that term.

To be appointed to a numbered seat, you must live in that City Council district. For example, the person appointed to Seat 5-A will be a resident in the fifth City Council district.

5. Neighborhood Emergency Contacts to Meet in February

Knoxville Fire Chief Stan Sharp and Knoxville Police Chief David Rausch will be on hand on Tuesday, Feb. 9, to welcome the Knoxville citizens who have volunteered to serve as neighborhood contacts in the event of a widespread emergency.

The Office of Neighborhoods and the Knoxville Knox County Emergency Management Agency (KEMA) are organizing the event, which will be held at the Emergency Operations Center, where the 911 Center is housed. Volunteers will learn about potential emergencies requiring their assistance and will meet key emergency agency personnel, including Chief Sharp and Chief Rausch.

Twenty-five city neighborhoods have identified their emergency contacts. The latest to the join the list are Cagle Terrace, RiverHill Gateway and Vestal.

6. Saturday Hotline to Address Possible Codes Violations

The City of Knoxville will launch a new inspections hotline to handle complaints on Saturdays, beginning Jan. 23.

When activated later this week, the hotline – 865-755-2531 – will be a complaint-driven service to address concerns about issues such as possible zoning violations, non-permitted construction, abandoned vehicles and dirty lots.

Between 8 a.m. and 4:30 p.m. on Saturdays, a City inspector will answer calls and visit sites of concern. The hotline is a pilot program that City officials hope will help close a gap. Until now, citizen concerns about non-permitted construction work or other code violations occurring on weekends could not be reported until Monday morning, by which time the violation may have ceased.

"There have been times when a City resident has wanted to talk about remedying a code violation occurring on a Saturday but our inspectors were off the clock," said Peter Ahrens, the City's Director of Plans Review and Inspections.

"We hope this new Saturday inspections hotline will close the gap and ensure that residential and commercial construction projects are executed through proper permitting to ensure basic safety standards are met."

Property owners unsure about commercial construction permitting can call 311 during weekday business hours to speak with Plans Review and Inspections office staff. Business owners also can contact Patricia Robledo, the City's Business Liaison in the Office of Business Support, at 865-215-3155.

For residential construction projects, citizens can check a list of items that require permitting by visiting www.knoxvilletn.gov/plansreview or by calling 311 during regular business hours.

7. Apply for Free Weatherization This Saturday

If you have not yet applied to the Knoxville Extreme Energy Makeover weatherization program (KEEM), now is your chance.

KEEM will be holding a special after-hours application session this coming Saturday, Jan. 23, from 9 a.m. until 1 p.m. at CAC's Housing and Energy Office, 2247 Western Ave. First, be sure you are eligible by calling CAC at 244-3080 or visiting the website at www.KEEMteam.com.

KEEM is a two-year, TVA-funded program that will provide energy efficiency and weatherization retrofits to over 1,200 low- and moderate-income homes in Knoxville. Eligible homes will receive upgrades that increase in-home comfort and reduce electricity consumption by an estimated 25 percent.

The KEEM Team is led by the Knoxville-Knox County CAC in partnership with the City of Knoxville, Knoxville Utilities Board, and the Alliance to Save Energy. KEEM supports the Smarter Cities Partnership, a coalition of more than 20 community organizations seeking to improve the quality, comfort, and affordability of Knoxville homes through energy efficiency.

8. Mayor Taps Reid to Succeed Strickland in Community Relations

Mayor Madeline Rogero has named Dr. Avice E. Reid as the City of Knoxville's Senior Director of Community Relations, replacing Thomas "Tank" Strickland, who will retire at the end of this month.

Reid, a Knoxville native and graduate of Knoxville College, joined the City in 2007 as Executive Director of PARC, which provides independent review of police actions, in response to citizen complaints. Prior to that, she spent 34 years at the Tennessee Valley Authority in roles including Senior Project Manager and Senior Manager of Information Technology.

In her new role, Reid will supervise community engagement efforts including the City's Save Our Sons initiative, the Police Advisory and Review Committee (PARC), and the Equal Business Opportunity Program, among other responsibilities.
