*** In an "active shooter" or terrorist situation, what should your response be, as recommended by emergency services?

Not quite prepared to answer these questions? Then come to the Citizen Preparedness Workshop from 6 p.m. to 8:30 p.m. tomorrow --- Wednesday, April 20 --- at O'Connor Senior Center, 611 Winona Street. Refreshments will be served.

This workshop is sponsored by the Knoxville Police Department (KPD), the Knoxville-Knox County Emergency Management Agency (KEMA), and the Office of Neighborhoods.

KPD Sergeant Sammy Shaffer will provide detailed insight and advice on how to respond in active shooter situations and to acts of terrorism. KEMA Director Colin Ickes will discuss community preparedness for and response to natural and manmade disasters. Rebecca McIver of the Office of Neighborhoods will outline how your city neighborhood can participate in the Neighborhood Emergency Preparedness Program.

2. City Announces Public Meetings on Traffic Calming

The City of Knoxville has scheduled two public meetings on a proposed new Neighborhood Traffic Safety Program for residential neighborhoods.

The meetings --- with identical presentations --- will be held:

*** Thursday, May 12, 5:30-7 p.m., at O'Connor Senior Center, 611 Winona Street *** Monday, May 16, 7-8:30 p.m., at West High School, 3300 Sutherland Avenue

Please mark these dates in your calendar and plan to attend one of the two meetings.

The program has been developed jointly by the Engineering Department, Police Department, and Office of Neighborhoods. For qualifying neighborhoods, the program will include enforcement, education and the use of traffic calming measures such as speed humps, traffic circles and traffic diversions.

Details will be available when program documents are released no later than May 3, and the public comment period will last through the end of May. The program is expected to launch in mid-summer.

7. North Hills Garden Club Holds Plant Sale Saturday

Rain or shine, the North Hills Garden Club will conduct its annual plant sale from 10 a.m. until 2 p.m. this coming Saturday, April 23, at North Hills Park on Kennington Road.

8. MPC Upholds R-1 Zone in Norwood

The Metropolitan Planning Commission (MPC) last week denied a request by a car dealership to rezone property bordering a residential street in the Norwood neighborhood.

Fenton Nissan, 4515 Clinton Highway, asked to rezone the rear of its property from R-1 (Low Density Residential) to C-4 (Highway Commercial). Bordering Tillery Road, the residentially zoned portion is needed to park overflow cars, according to Knoxville Attorney Arthur Seymour, Jr., who represented the auto dealer at the monthly MPC meeting.

MPC staff concluded that the "general commercial use of this site... would be compatible with the surrounding land uses and zoning pattern." It recommended the rezoning on the conditions that there be no access to Tillery Road, where most properties are residential in both zoning and use, and that the dealership install a 15foot-wide landscaped buffer along Tillery.

Lynn Redmon, president of the Norwood Homeowners Association, said the Nissan parcel and two others were zoned R-1 years ago as part of a compromise to protect the neighborhood. Grant C-4 on the Nissan parcel, he said, and there would be no reason not to grant C-4 to neighboring parcels that were also part of the compromise.

He also noted that, while Fenton Nissan might intend to use the parcel only for storing cars, a subsequent owner of the property would have the right to any use allowed in C-4, which Redmon described as "a rough zone."

MPC Commissioner Bart Cary noted that, just as the C-4 zone would run with the land, so would the landscaped buffer and no-access requirements. He thought the neighborhood would actually get a better screen as a result of the rezoning.

But Commissioner Laura Cole opined that C-4 would be too close to the residences on Tillery. Commissioner Art Clancy concurred, and his motion to deny the rezoning request was approved by the commission.

9. MPC Ready to Discuss Bearden Mixed Use Zone

The Metropolitan Planning Commission (MPC) n early May will host a public meeting to present the proposed Mixed Use District zoning for the Bearden Village area.

The meeting will start at 6 p.m. Tuesday, May 3, at Bearden Unite Methodist Church, 4407 Sutherland Avenue. MPC staff will present the general concepts of the proposed zoning and will provide an opportunity for questions and input from the audience.

In 2001, the <u>Bearden Village Opportunities Plan</u> --- developed with input from the community --- focused on three goals: 1) enhance pedestrian activity and access, 2)

enhance the sense of place and community, and 3) build upon Bearden's urban character and unique atmosphere.

To accomplish these goals, the plan makes several recommendations on how to transform the Bearden area into an "urban village", defined as "a complete and integrated community of housing, shops, workplaces, schools, parks and civic facilities within easy walking distance of each other."

In order to realize the Bearden Village concept, City Council last year requested that MPC staff consider options for more residential uses in the non-residential portions of the Bearden area. Staff determined that the existing zoning is not adequate to simply allow residential uses and that a new mixed use zone is needed to allow a range of uses and to give greater priority to pedestrians.

10. BZA Decisions Can Impact Your Neighborhood

Seventeen properties are on the agenda for this month's meeting of the Board of Zoning Appeals (BZA) at 4 p.m. Thursday, April 21, in the Small Assembly Room of the City County Building.

Established by city ordinance, BZA hears appeals of denials of building permits by the city's Building Inspections Department. The board, consisting of five citizens appointed by the Mayor, meets on the third Thursday of each month.

Addresses on the agenda include 2308 Forest Avenue, 220 Carrick Street, 4125 McKinley Street, 5101 Kesterwood Court, 10248 Kingston Pike, 953 E. Moody Avenue, 333 Depot Avenue, 1500 Lyons Bend Road, 6520 Baum Drive, 103 Midlake Drive, 517 E. Oklahoma Avenue, 1995 Henley Street, 313 W. Blount Avenue, 5429 Pleasant Ridge Road, 1830 Cumberland Avenue, 10461 Parkside Drive, and 6400 Sherwood Drive.

Keep up with how the BZA might impact your neighborhood. Watch for the black and white signs indicating that there is a pending decision on a particular piece of property. Most signs are for Metropolitan Planning Commission issues --- which are also important --- but signs with the word "variance" are BZA items.

The BZA agenda is posted on the city website. Browse to <u>www.knoxvilletn.gov/boards</u> and click on Board of Zoning Appeals. The agenda is posted no later than the Monday prior to the BZA meeting each month.

A neighborhood group that keeps track of BZA will call the Plans Review & Inspections Department at 215-3669 to request and study the paperwork on a particular appeal, decide whether to take a position on the appeal, and then attend the BZA meeting to voice the group's support or objections. A group can also request a postponement to allow time to meet with the applicant. Decisions of the BZA can be appealed within 15 days of the BZA decision to Knoxville City Council. Appeals of a City Council decision are made to Chancery Court within 60 days of a City Council decision related to BZA.

11. City Targets Three Neighborhoods for Codes Sweeps

The City of Knoxville's Codes Enforcement Office will conduct a "codes sweep" in each of three neighborhoods this year.

During a codes sweep, all of the city's codes inspectors spend several hours in the same neighborhood, walking from door to door to identify any violations of the city's codes governing buildings, dirty and overgrown lots, and abandoned vehicles. Owners of or residents in a property with a codes violation are given a brochure identifying and explaining the violation.

The owner is given two weeks to cure the violation. If not cured after that time, a formal Notice of Violation is issued.

Neighborhoods that will get codes sweeps this year are Edgewood Park, April 21; Old North Knoxville, May 25; and Fourth & Gill, September 14.

These neighborhoods were selected in consultation with the Knox County Health Department. Along with the usual violation identification and education, inspectors will be collecting data to assist the Health Department with its "Project Diabetes Sidewalk Obstruction Campaign".

12. Bring Police Concerns to PARC Next Week

The <u>Police Advisory and Review Committee</u> (PARC) is a civilian oversight committee that audits the discipline process and the policies and procedures of the Knoxville Police Department (KPD).

The purpose is to strengthen the relationship between the citizens of the City of Knoxville and the KPD; to assure timely, fair and objective review of citizen complaints while protecting the individual rights of police officers; and to make recommendations concerning citizen complaints to the Chief of Police and to the Mayor.

By making sure citizen concerns are addressed by an independent body, PARC aims to improve the relationship between members of KPD and the citizens they serve.

PARC meets quarterly, and its next meeting is at 6 p.m. Thursday, April 21, in the Small Assembly Room of the City County Building, 400 Main Street. At this meeting, KPD Sgt. Tom Walker will explain how KPD officers can now administer the drug naloxone in an effort to save the life of someone who has overdosed on narcotics.
