### 1. Timbercrest Issues a Wiffle Ball Challenge to Other Neighborhoods

Sparked by an idea from Jennifer Reynolds, the Timbercrest Neighborhood Association is challenging other neighborhood groups to participate in a friendly but competitive Wiffle Ball Tournament later this year.

Jennifer has gained the backing of the City of Knoxville's Parks & Recreation Department. At this time, she is seeking interested neighborhoods.

If you have never heard of or played Wiffle ball, that is okay. This is an opportunity to get together with neighbors, have fun, and get to know residents of other neighborhood groups.

The number of neighborhoods wishing to participate will determine where the event is held. Jennifer is hoping to stage the tournament toward the end of spring or the first part of summer. #### 2. Registration Begins Next Week for March 11 Neighborhood Conference

Preparations are now well underway for The Neighborhood Conference --- now less than six weeks away on Saturday, March 11, at the Knoxville Convention Center.

Online registration will begin next Tuesday, Feb. 7, and last four weeks, ending at noon Tuesday, March 7. There is no charge to attend, but all participants must register.

The conference will include a neighborhood tee shirt contest, 22 workshops, over 80 information booths, continental breakfast, a welcome session with Mayors Madeline Rogero and Tim Burchett, special workshops for middle and high school students, a slideshow of neighborhood photographs, time to network with neighborhood activists and government officials, a luncheon that includes the presentation of the Neighbor of the Year Award, and door prizes.

Plan now to attend this event that is designed for the benefit of Knoxville's residential neighborhoods.

#### 3. Eight Residents Nominated for Good Neighbor of the Year Award

Eight Knoxville neighborhood residents were nominated for the Diana Conn Good Neighbor of the Year Award, and they will be honored at the City of Knoxville's Neighborhood Conference on Saturday, March 11, at the Knoxville Convention Center.

The eight were nominated by their neighbors in response to a call from the Office of Neighborhoods last December. All will be honored, but only one will receive the Award.

Named for the late Diana Conn of the Old Sevier Community, the Award is presented annually to a Knoxville resident who --- in a spirit of cooperation and with commitment to inclusive community --- has devoted time and talent in service to his or her neighbors and neighborhood.

Booths can be set up from 2-4 p.m. on Friday, March 10, and must be ready when doors open to attendees at 7:30 a.m. Saturday, March 11. The conference lasts until about 2:30 p.m., but booths may be dismantled after 12:15 p.m.

Inas is a native of Iraq. She and her husband came to Knoxville about two years ago so that he could work on a PhD from UT in engineering.

In Iraq, Inas worked for a US-based non-governmental organization --- Global Communities --- that offers micro-finance loans for entrepreneurs. She started as a credit assistant in July of 2005 and rose through the ranks in a male-dominated profession to become a treasury manager in 2013 and 2014. In the latter position, she was responsible for identifying, monitoring, and managing the institution's daily financial position and risks; evaluating new funding sources in Iraq; and monitoring the lending process, foreign exchange, credit, and country risks.

Inas comes to the City by way of a new nonprofit program, <u>Invest Knoxville</u>, whose mission is to locate internships, temporary employment, and long-term employment for immigrants who had professional training and careers in their home countries but who need some resumé-building job experience here.

#### 8. Workshop: Should Neighborhoods Focus on Problems or Assets?

It is not uncommon for attendance at neighborhood meetings to rise dramatically if there is a problem in the neighborhood....and then go right back down if the problem goes away or seems to be too difficult to tackle.

What happens when a neighborhood organization focuses solely on "problems" in the neighborhood? What would happen if attention is focused on the neighborhood's assets? What is a neighborhood's most important asset?

These will be among the questions posed and discussed at this month's installment of the "Building Strong Neighborhood Organizations" monthly workshop series.

The workshop will be held Thursday evening, Feb. 9, at a location still to be determined. City neighborhood groups are invited to attend and participate, as are individuals who are thinking about starting a neighborhood organization. Doors will open at 5:30 p.m. Light refreshments will be served, but bring your own water. The workshop will begin promptly at 6 p.m. and last no later than 8 p.m.

## 9. Emergency Contact Network Now Uses Text Messaging

The Knoxville-Knox County Emergency Management Agency (KEMA) --- in partnership with the City's Office of Neighborhoods --- is now using text messaging to communicate with members of the Emergency Contact Network.

The Network is composed of volunteers throughout Knoxville and Knox County who make themselves available to report on conditions in their neighborhoods during widespread emergencies.

"We have previously relied on phone calls or emails to contact our volunteers during an emergency," explained Wyatt Pless, an AmeriCorps member who works on the project from the Office of Neighborhoods. "However, these two methods are not necessarily reliable if there are downed power and phone lines. Text messages often get through even if voice communications are down."

Thanks to an app that can be used for such communications, the Emergency Operations Center (EOC) can now send a mass text message to every volunteer and receive reports through the app. This will greatly decrease the time needed to send and receive reports within the Network.

Since it was first organized in 2016, the Contact Network has grown to 51 individuals, but more volunteers are needed. Make sure your neighborhood is covered and represented. Contact Wyatt Pless at 215-3456 or <a href="mailto:wpless@knoxvilletn.gov">wpless@knoxvilletn.gov</a>.

#### 10. Thinking Spring Cleanup? Schedule a Trash Container Soon

If your neighborhood organization is thinking about scheduling a cleanup event this year, and you need a large trash container provided by the city, then now is the time to reserve your container.

The Public Service Department (PSD) offers trash containers free of charge to neighborhood groups for neighborhood-wide cleanup projects, but there are a limited number of containers and crews to handle them, so it is a very good idea to schedule your container as soon as you nail the dates for your cleanup event.

PSD offers two types of drop-off containers --- trailers and courtesy boxes. A trailer is familiar to anyone who has seen a city crew picking up brush. It is on wheels, is very large and has high sides, meaning it takes some muscle to pitch in heavy items. It is most appropriate for large-scale cleanup projects. A courtesy box is about one-third the size of a trailer, is easier to fill because the sides are not as high, and is more appropriate for neighborhood cleanups.

Call 311 to schedule a container on a first-come, first-served basis. Try to do this at least 6-8 weeks in advance of your cleanup event. Weekends (drop off Friday, pick up Monday) are in greater demand; mid-week slots are easier to schedule.

To insure proper location, a neighborhood representative should be prepared to give the 311 operator a daytime phone number for follow-up questions.

Anyone requesting a container must also provide a location where it is to be dropped. Make sure the spot is relatively level and is large enough for the container and the cab dropping it off. If the drop-off spot is not paved, it should have enough gravel so that the container does not get stuck in mud.

You may wish to check with nearby neighbors to make sure the location is acceptable to them. Also, if vehicles are blocking the designated spot, the city crew will not leave the container.

This program is available for residential and neighborhood use only --- not contractors, businesses and landlords. Also, please do NOT use containers for dirt, concrete, tires, construction debris, gas, paint and chemicals. Violators may be cited and may be prohibited from scheduling another container.

## 11. South Knoxville Street to Close for 90 Days

A section of West Blount Avenue west of Chapman Highway will be closed for 90 days beginning Monday, Feb. 6, while a contractor installs sewer main connections and storm drains.

The utility work is being performed by Charles Blalock & Sons Inc. as part of the construction of two South Waterfront residential developments – the \$60 million Riverwalk at the Bridges apartments at the former Baptist Hospital site and the \$35

million Riverfront Station student apartment complex, just west of the Henley Bridge. Electrical work by KUB is also anticipated during this street closure.

During the installation, West Blount Avenue will be closed between Chapman Highway and the railroad overpass near St. Paul Street. Motorists will be rerouted around the work site, accessing Blount Avenue from Martin Mill Pike or Maryville Pike.

Pedestrians should anticipate some sidewalk closures along sections of Chapman Highway and Blount Avenue within the project area, but signs will be in place to notify pedestrians of alternative paths.

The Riverwalk at the Bridges development will include 300 residential units and public amenities that include a 1,100-foot public riverwalk, a center plaza between the east and west residences, a pocket park, and a 37,500-square-foot public plaza at the Henley Bridge.

The Riverfront Station student housing development will be a five- to six-story apartment complex that will be home to more than 400 students. Its riverwalk will connect to the new residences on the former hospital site and eventually will tie in to the existing Cityview riverwalk.

Riverwalk at the Bridges is tentatively scheduled to open its first units in late 2017, while Riverfront Station is scheduled to open in the fall of 2018.

#### 12. MPC Schedules Public Meetings for One Year Plan Update

The Metropolitan Planning Commission (MPC) has scheduled three meetings to gather public input for its annual update of the One Year Plan, a comprehensive development plan that covers the entire city and sets parameters for zoning decisions.

At these meetings, MPC staff will be present to discuss amendments occurring in the previous year, proposed amendments for newly annexed property, and proposed staff amendments for 2017. To see the 2016 One Year Plan and other details, visit <a href="this MPC">this MPC</a> <a href="page">page</a>.
