- --- Activities involved in launching, reviving, or strengthening a neighborhood group.

### 5. Welcome New City Council Members!

This past Saturday, Dec. 16 2017, five new city council members were sworn in and a new Vice Mayor was voted in.

The new city council members are Stephanie Welch (first district), Andrew Roberto (second district), Seema Singh-Perez (third district), Lauren Rider (fourth district), and Gwen McKenzie (sixth district). Finbarr Saunders, sitting Council member (At Large Seat C) was selected as Vice Mayor by his fellow Council members.

As Vice Mayor, Saunders' responsibilities include: representing the city in the absence of Mayor Rogero, supervision for the council's office team of three, and acting as liaison between the mayor's office and the council itself. Vice Mayor Saunders will remain a councilmember.

Their first meeting on City Council is tonight, Tuesday, Dec. 19, at 6 p.m. in the Large Assembly Room of the City County Building.

### 6. Garbage and Recycling Schedule Is Posted for the Holidays

Waste Connections, the City's household garbage and recycling hauler, is closed on Monday, Dec. 25. Garbage and recycling will not be collected that day. Residential and downtown collections typically scheduled for Monday collection will resume Tuesday, and the collection schedule will offset by one day for the remainder of the week.

Though garbage and recycling will be collected on Monday, Jan. 1, 2018, the Waste Connections offices will be closed. (The only holidays on which Waste Connections does not pick up are Thanksgiving and Christmas Day.)

Following the Christmas holiday properly bagged excess holiday household trash and broken-down cardboard set next to full garbage carts will be picked up – a one-time exception to the requirement that all bags be placed inside carts.

The City's recycling centers will be open for recycling drop-offs, but the Goodwill attendant will only be available for donations of household goods for a half-day (until 1 p.m.) on Sunday, Dec. 24. The center will be unstaffed but open for recycling drop-off on Monday, Dec. 25, and Monday, Jan. 1.

The City's Solid Waste Management Facility, 1033 Elm St., will be closed from Saturday, Dec. 23, through Monday, Dec. 25, with normal hours resuming on Tuesday, Dec. 26. For the New Year's holiday, the facility will be closed from Saturday, Dec. 30, through Monday, Jan. 1, with normal hours resuming Tuesday, Jan. 2.

#### 7. Winter Temperatures Here, City Ready with Snow Plan

It appears that Knoxville has dodged its first potential snow of the season, with a threatening weather system moving further south. Nevertheless, frosty temperatures have arrived, and City crews stand ready with the official Snow and Ice Removal Plan.

"Our weather in East Tennessee can be especially unpredictable, so we work diligently year-round to ensure that we're at our best possible capacity and prepared for whatever comes our way," notes Chad Weth, Director of Public Service, in the City's press release.

The <u>Snow and Ice Removal Plan</u> prioritizes treatment by category. Streets are placed in three categories, with the Level 1 streets getting top priority:

- --- Level 1 Main streets carrying the highest volume of traffic, hospital routes, and Knoxville Area Transit emergency routes;
- --- Level 2 Streets connecting the main streets, feeder streets to connector streets, trouble spots, and hills; and
- --- Level 3 Streets providing access to neighborhoods and main connections at the neighborhood level.

Roughly 470 lane miles are treated for Level 1 and 2 streets in the City's limits. Level 3 streets are treated as resources are available, once higher-priority and heavier-traveled routes are cleared.

Snow preparations are a year-round effort involving equipment inspections, Snow and Ice Removal Plan updates (made each fall), brine and salt inventory upkeep, and more. When it comes to snow, the City has a multi-faceted arsenal.

The Recode Knoxville project is an update to the City of Knoxville's zoning ordinance. It is an opportunity to protect the things each of us value about our neighborhoods and commercial areas while allowing the kinds of smart, sustainable growth that will move Knoxville forward. It is a 21<sup>st</sup> century code that is easier to use, easier to administer, and will be a blueprint for the future. The project goals are: to support investment, protect things uniquely Knoxville, and connect our community.

#### 9. MLK Commemorative Commission Releases Events Schedule

The Martin Luther King Jr. (MLK) Commemorative Commission has a multitude of events in the week leading up to and through Jan. 15, 2018, the birthday of and designated holiday date for Martin Luther King Jr.

Events begin with a gallery tribute on Jan. 5, and close with a performance by the Knoxville Symphony Chamber Orchestra on Jan. 15. MLK day also includes the annual MLK Day Parade, one of the most popular MLK events. The parade culminates at Overcoming Believers Church (OBC), 211 Harriet Tubman St., the host of the Memorial Tribute Service.

The week's events feature two keynote speakers. Chairman John Hope Bryant is the keynote speaker for the 2018 Leadership Awards Luncheon on Thursday, Jan 11. Bryant is the founder and chairman for the non-profit Operation HOPE, which provides youth and adults with financial literacy skills.

The 2018 Memorial Tribute Service Keynote Speaker is Rev. Dr. Otis Moss Jr., a close friend of Dr. Martin Luther King Jr. and civil rights activist. The Memorial Tribute Service begins at 11:45 a.m. on Monday, Jan. 15 at OBC.

The Martin Luther King Jr. Commemorative Commission is a non-profit composed entirely of volunteers.
