### 1. Next Mandatory Grant Workshop this Saturday

The Office of Neighborhoods has launched the 2019 season for the Neighborhood Small Grants Program (NSGP).

To apply for a grant under the NSGP and you did not attend last Saturday's workshop; your organization must send a representative to ONE of the following mandatory workshops:

- \*\*\* Sat., June 2, 10 a.m.-12 noon
- \*\*\* Thurs., June 14, 6-8 p.m.

Even if you are unsure whether your neighborhood group will apply this year, sending a representative ensures that you are eligible to apply. Participation can also assist your group in planning for a 2020 grant application.

Under a new meeting format started in May 2018, NWG will now review blighted properties on odd-numbered months, and hear from city officials and other speakers on blighted property issues and related topics on even-numbered months. The group always meets on first Thursdays at the time and location indicated above.
