2. The Neighborhood Conference Highlights Success of

The 2019 Neighborhood Conference was held on Saturday, May 18, with 500 neighborhood attendees and 70 different neighborhood organizations represented.

The day provided many winning moments. Everyone got a gift certificate for a free moon pie at Mast General Store; many walked away with door prizes; people learned at workshops about traffic calming, affordable housing, or neighbor engagement and recruitment; and, people networked with booth staff and fellow neighborhood leaders.

The awards luncheon honored inspiring neighbors and neighborhoods for their commitment to community. Eight neighborhoods were honored for their hard work over

the past year: Historic Fourth and Gill, RiverHill Gateway Neighborhood, South Woodlawn Neighborhood Association, The Highlands Home Owners Association, The Residence of Eastport, Timbercrest Neighborhood Association, Wesley Neighbors Community Association, and West Hills Community Association.

Additionally, the 2019 winner of the Diana Conn Good Neighbor of the Year award was presented to Katy Hawley, from Historic Fourth and Gill. Katy was deserving of the award for all her hard work for her neighborhood and behind the scenes.

A huge thank you goes out to all those that participated and helped make this a great event. Even though the event originates with the Office of Neighborhoods, it is a team effort involving many City departments, sponsors, and volunteers.

3. First Mandatory Grant Workshop This Thursday

The Office of Neighborhoods kicks off the 2020 Neighborhood Small Grants Program (NSGP) this year, with the first opportunity to attend a mandatory grant workshop on Thursday, May 30.

The NGSP allows neighborhoods to apply for up to \$3,000, to tackle a neighborhood project or carry out an event or an idea that benefits the whole neighborhood.

To apply for a grant under the NSGP, your organization must send a representative to ONE of the following mandatory workshops:

- *** Thursday, May 30, 6-8 p.m.
- *** Wednesday, Jun 5, 6-8 p.m.
- *** Saturday, Jun 8, 10-12 noon

All three opportunities will be held at the Public Works Building, 3131 Morris Ave.

All applicants MUST have at least one neighbor participate in at least one workshop to be eligible. Participation is encouraged even if no current plans are in place – to assist your group in final consideration for an application for the current year or to assist in planning for a 2021 grant application.

Proposals are due Monday, July 29, and will be judged on a competitive basis. Submit proposals on or before Monday, July 22 to have staff review your application for completeness.

4. Does Your Neighborhood Org. Want to Host an Event at a City Facility/Park?

The City of Knoxville Parks and Recreation Department along with the Office of Special Events has made it easier for your neighborhood organization to reserve a space at any local City Park or Facility.

<u>Here</u> are some easy instructions to follow to reserve a space for your neighborhood event. For the most part, there will be no charge at City parks. You may need insurance if you are doing a large event and bringing in external amenities such as bounce houses, etc. But if it is a party, picnic, pot luck, or gathering, it should be free for neighborhood organizations.

5. Challenge Grant Applications Due This Week

The deadline is approaching for the annual Challenge grants. Applications are due by 4:30 p.m., Thursday, May 30, to be considered.

Does your neighborhood have a park or public space? Would you like to give that space a little extra care, add some amenities, or even start a community garden? Check out Parks and Recreation's Challenge Grant Program.

The Challenge Grant, separate from the <u>Neighborhood Small Grants Program</u>, offers non-profits, neighborhoods, and other community organizations the opportunity to apply for funds that improve public spaces.

Recipients of the Challenge Grant will be reimbursed up to 50 percent for a single project, up to \$2,500.

6. City Council to Hold Special Meeting on Recode

City Council will meet Thursday, May 30, to continue their discussion on Recode. The meeting will begin at 3 p.m., in the Main Assembly Room of the City County Building, 400 Main St.

Recode Knoxville is a comprehensive update to Knoxville's 50+ year old zoning code. Zoning codes help the City and the Planning Commission determine what types of structures, businesses, and developments can go in which areas. Recode Knoxville focuses on both updating the current zoning code to reflect actual usage across the city and planning for Knoxville's future expansion.

7. Public Service Reps Available for Neighborhood Meetings

Is your neighborhood association interested in having a member of the City's Public Service Department attend meetings and answer questions?

After the Neighborhood Conference last week, a resounding number of people answered 'yes' to that question. To increase outreach and provide information about City services, Public Service representatives will be available to attend your neighborhood meetings. They can answer questions regarding brush and leaf pickup, trash and recycling, right-of-way mowing, and all other neighborhood maintenance provided by Public Service.

8. BBB and POH Meetings Are This Week

The Better Building Board (BBB) and Public Officer Hearings (POH) are scheduled for this week.

The BBB will meet on Thursday, May 30, at 3:30 p.m., the POH will meet at 9:30 a.m., on Friday, May 31, both in the Small Assembly Room of the City County Building, 400 Main St.

For the BBB, there are two properties listed: 925 Farragut Ave. – Appeal of Public Officer Order, and 1027 Gratz St. – Demolition by neglect.

For the POH, there are 11 properties listed: 141 Atlantic Ave.; 524 Cedar Ave.; 4100 Cottonwood Dr. – Swimming pool and all accessory structures; 1805 Forest Ave; 3733 Frostwood Rd.; 5717 Kentwood Rd.; 0 Murray Dr. – Swimming pool only; 2523 Riverside Dr. – Confirmation of emergency repair only order; 3225 Shields Ave.; 414 East Springdale Ave.; and 2821 Selma Ave. – Boarding Approval.

Neighbors can benefit from following the BBB and the POH to advocate for the demolition of blighted and troublesome buildings in your neighborhood.

9. Knoxville Hosts USA Cycling National Championships

For the third consecutive year, Knoxville will host the <u>USA Cycling Pro Road National Championships</u>! This year, the Para-Cycling National Championships will also be held in Knoxville.

This year's events will take place June 27-30, with races held on Friday, June 28, Saturday, June 29, and Sunday, June 30.

The USA Cycling weekend is a fun, community-wide event. Neighbors are encouraged to come out and cheer, make signs, and be a part of the excitement. Unfortunately, to host such a major event here on our streets, the City will also experience road closures and changes in traffic patterns during that time. - *** Friday, June 28, 4 to 9 p.m.: Expect road closures on S. Gay St., W. Hill Ave., and Hall of Fame Dr.
- *** Saturday, June 29, 7 a.m. to 3 p.m.: Expect road closures on James White Parkway.
- *** Sunday, June 30, 8:45 a.m. to 7 p.m.: Expect road closures throughout Downtown and South Knoxville.
