1. Neighborhood Recognition Dinner Announces OLOYA, NOYA, NAA Winners

In honor of those neighbors who go above and beyond for the community, the Office of Neighborhoods (OON) hosted a Neighborhood Recognition Dinner on Thursday, July 23, outside the soon-to-be City Safety Complex.

A small group of neighbors, City Council Members, the Mayor, and City staff gathered for a socially distanced dinner to recognize those neighbors nominated for the Officer Liaison of the Year Award (OLOYA), The Diana Conn Good Neighbor of the Year Award (NOYA), and the Neighborhood Achievement Awards (NAA). Nominees enjoyed a dinner catered by Jackie's Dream, mingled with the Mayor and OON staff, and enjoyed a nice evening of positivity and fellowship.

The Mayor presented proclamations to all the NOYA nominees and announced the winner of the 2020 Diana Conn Good Neighbor of the Year Award: Anne Crais of the **West Hills and Wesley Neighbors Community Associations**.

The Diana Conn Good Neighbor of the Year Award is awarded to neighbors who commit their time and energy to the good of the neighborhood and do not seek recognition for their contributions. As the secretary of the Wesley Neighbors Community Association since 2012, Crais has dedicated countless hours to Wesley Neighbors and West Hills associations, taking notes, planning events, organizing Healthier TN activities, and much more.

Additionally, the Neighborhood Recognition Dinner recognized the following neighborhoods for community-building projects and creative indicatives with the NAA:

• Forest Heights Neighborhood Association, Community Wildlife Habitat

The Mayor presented NAA awardees with proclamations and a \$75 check is on its way for each neighborhood to put toward future projects.

Officer Liaisons nominated for the OLOYA award last year during the Oct. 1, National Night Out were also recognized. Eric Parks, the Officer Liaison for the Norwood Community was announced the OLOYA winner, last year, and received a proclamation, as well.

The OLOYA, NOYA, and NAA awards were meant to be presented at the 2020 Neighborhood Conference. However, due to COVID-19, the conference was canceled. The Neighborhood Recognition Dinner served as a smaller, socially-distanced effort to recognize 2020 nominees and awardees despite the cancelation of the conference.

2. City Council to Vote on KPD Body Cameras

On this week's City Council <u>agenda</u>, council members will vote on a contract for 350 new police body cameras and 350 upgraded police cruiser cameras.

At the regularly scheduled City Council meeting, held this Tuesday, July 28, at 6 p.m., via Zoom, Council will be asked to authorize Mayor Kincannon in executing the steps necessary to move forward with a five-year contract with Axon Enterprise. Axon Enterprise is the leading bidder out of seven proposals to provide the Knoxville Police Department (KPD) with new body cameras and updated cruiser cameras. The City evaluation team deemed Axon's proposal most responsive, and recommended signing the 5-year, \$4.9 million dollar contract with the company. The contract covers ongoing

operational costs and has the possibility to be extended, should the City choose to move forward with Axon in the future.

The new body cameras and updated cruiser cameras have been a long-discussed desire for KPD and the community. In the City's press release, Mayor Kincannon stated, "The community wants this, KPD wants this, and we're working hard to get this implemented as soon as possible."

If approved by City Council, City staff hopes to finalize and execute the process for camera installation to go in as early as this fall.

3. Last Day to Early Vote or Request an Absentee Ballot

The last day for Early Voting is this Saturday, August 1st.

If you do plan to vote in person, early voting may be a good option to help avoid crowds. Instead of voting at your polling location, Knox County residents may early vote at any of the following locations:

City County Building Small Assembly Room, 400 Main St. (Check special schedule.) Knoxville Expo Center (North), 5441 Clinton Hwy. Love Kitchen, 2418 Martin Luther King Jr. Ave. Farragut Town Hall, 11408 Municipal Center Dr. Downtown West, 1645 Downtown West Blvd. Carter Library, 9036 Asheville Hwy. New Harvest Park, 4775 New Harvest Ln. Halls Recreation Center, 6933 Recreation Ln. Meridian Baptist Church (South), 6513 Chapman Hwy. (Check special schedule.) Karns Senior Center, 8042 Oak Ridge Hwy. (Check special schedule.)

Unless marked above, general early voting hours run from 10 a.m.-6 p.m., Monday through Friday, from July 17-28, with extended hours from 10 a.m.-7 p.m., July 29-31. Voters can also early vote on Saturday July 18, 25, and Aug. 1, from 11 a.m.-5 p.m.

Are you concerned about voting in person? Absentee ballots must be received in time for your county election commission to count it, no later than the close of polls on election day, Thursday, Aug. 6. First time voters, however, must vote in person.

7. 2020 Landlord Summit Offers Resources to Keep Tenants Housed

There will be a free Landlord Summit on Wednesday, Aug. 5, and Thursday, Aug 6.

This webinar will present useful information for landlords about the CARES act, the new House Knox Housing Navigator program, and how to help tenants who are Knoxville residents, access financial assistance to help with rent and utility debt due to COVID.

For the first webinar on Wednesday, Aug 5, at 12:30 p.m., there will be three speakers to discuss different financial options:

Michael King with Paine, Tarwater, Bickers, LLP will discuss how the CARES Act impacts landlords; Hope Ealey with the City of Knoxville Community Housing and Neighborhood Development will discuss the City's programs to provide financial assistance to prevent the loss of housing for those affected by COVID-19; and Drew Holloway with United Way will discuss House Knox and the program's benefits for landlords.
