## 1. City Council Hosts Workshop

Knoxville City Council will hold a workshop at 4 p.m. on Thursday, Nov. 12, via Zoom video/audio conference. The following topics will be on the agenda: a review of TIFs (Tax Increment Financing) and PILOTs (Payment in Lieu of Taxes) for developments. The Knoxville Chamber will also provide an update on its five-year strategic vision and its fiscal year 2021 business plan.

# 4. CAC Requests You Apply for CARES Act Money by Nov. 30

The Knoxville-Knox County Community Action Committee (CAC) is asking applicants for its COVID-19 energy assistance funds to get their applications in by Monday, Nov. 30, to allow time for application processing before the deadline of Dec. 4.

If any member of your household has been affected by the COVID-19 pandemic in one of the following ways, you may qualify for energy assistance funds:

- Job loss, work-hour reduction, or loss of wages due to the COVID-19 pandemic
- Missed work to care for a child as a result of school closure, COVID-19 related illness, or online learning
- Missed work to care for an adult family member or relative with a COVID-19 diagnosis
- COVID-19-related out of pocket expenses
- Inability to find employment due to the pandemic
- Other COVID-19 related circumstances

Funds are not income based, and all who have suffered loss of income due to COVID-19 are encouraged to apply.

CARES Act Utility Assistance funding can be used to help pay for the cost of electric, natural gas, propane, wood, kerosene, or coal.

To apply, follow the <u>link</u> for a downloadable application. Send a completed application, a copy of your driver's license or photo ID, a copy of your most recent utility bill, and documentation of the COVID-19-related income loss to CAC using one of the following methods:

## 5. Did You Know Knoxville Has a Climate Council?

In September 2019, Knoxville City Council unanimously adopted two goals to combat climate change in Knoxville:

- A 50 percent reduction in greenhouse gases by 2030 for municipal operations
- An 80 percent reduction in greenhouse gases by 2050 for the entire community.

The Mayor's Climate Council, housed under the Office of Sustainability, is working to ensure that these goals are met. Their next meeting is today, Nov. 10, at 1:30 p.m.

Reducing Knoxville's carbon footprint is crucial to combating climate change, improving our ability to bounce back from disasters, protecting our health, and smartly utilizing taxpayer dollars.

Making Knoxville a leader in fighting climate change requires collaboration. To identify and evaluate strategies to achieve the 80 percent by 2050 community goal, Mayor Indya Kincannon has invited cross-sector leadership to take part in the Mayor's Climate Council. This group will include conservation advocates, clean-energy experts, advocates for equity, neighborhood representatives, developers and business leaders, and representatives from KUB and TVA. Collectively, they will work to find smart

solutions to promote sustainable redevelopment of our city while protecting green spaces and reducing our carbon emissions.

Whether you swim at Meads Quarry, hike Sharps Ridge, jog Third Creek Greenway or stroll the paved paths at Holston River Park, making Knoxville cleaner and greener makes us healthier, and catalyzes private investment, with corresponding growth in business and jobs.

There are four working groups comprised of dozens of community leaders and technical experts that provide ongoing guidance on the Council's priorities. These groups are: Equity, Transportation, Energy/Building Technology, and Waste Technology.

### 6. Planning Meets this Thursday

The Knoxville-Knox County Planning Commission will meet Thursday, Nov. 12, at 1:30 p.m. The meeting can be viewed live on <u>CTV</u> or <u>YouTube</u>.

On this week's agenda, Planning will discuss 56 agenda items. To view the full agenda, visit the <u>website</u>. To tell whether a property is in the city or county, read the description: City properties are listed as "Council Districts," and county properties are listed as "Commission Districts."

The Planning Commission hears cases on zoning changes, construction permits, road closures, and more. To learn about new developments and construction in your area, visit the Planning Commission each month and tune into their monthly meetings, every second Thursday of the month.

#### 7. Planning Introduces New Forms

There are several new Planning forms available to make it easier for community members to reach Knoxville-Knox County Planning staff, submit comments on cases, and sign up to speak at Planning commission meetings!

Previously, individuals could request to speak at a meeting by calling or emailing Commissioners or staff. Due to the frequency and volume of emails received each month, an online form was created to provide an additional way to sign up to speak and make the process easier.
