1. City Council Approved Six Neighborhood Small Grants

For the 2021 Neighborhood Small Grants cycle, six neighborhoods applied and were recommended to receive funding for their proposed projects.

Last Tuesday, Jan. 12, City Council voted to approve the funding.

The Neighborhood Small Grants Program (NSGP) allows neighborhoods to apply for small grants (up to \$3,000) to tackle projects important to their area. NSGP grants are designed to offer neighborhoods the ability to fund neighborhood-led projects specific to the unique character and needs of their neighborhood.

Neighborhoods that will receive funding from the 2021 Neighborhood Small Grants Program are: Fairmont-Emoriland Neighborhood Association, The Roseberry City Connection Community Organization, Town Hall East, South Woodlawn Neighborhood Association, Vestal Community Organization, and Westwood Homeowners' Association.

This year's recipients have a wide range of creative projects uniquely designed for bringing people together in their area, including bus shelters, rose bushes, bench installation and restoration, a welcome sign, a large community event.

The City Council committed to finding funding to help support the community that was displaced and economically disadvantaged during Urban Removal. This Task Force will help guide those efforts. Members must possess a reputation for fairness, integrity, responsibility, and have demonstrated an active interest in public affairs and service, and not be a current employee of any governmental body except those employed in the field of education. PARC members must be registered voters in the City of Knoxville.

Members are appointed by the Mayor and confirmed by Council. Terms are for a threeyear period. Members cannot serve more than two consecutive terms.
