<u>1. Primary Election Is Today</u>

If you want your voice heard, it is important to vote! The City Primary Election is being held today, Tuesday, Aug. 31.

If you did not get a chance to vote during Early Voting, you have one last chance to vote today. During Early Voting, you can vote at any of the polling sites; however, on Election Day, you must vote in your precinct. If you are unclear which precinct you are

in, try this handy <u>KGIS tool</u> or contact the Knox County Election Commission (KCEC) at 215-2480.

The top two winners in each district (1, 2, 3, 4, and 6) from today's election will go on to the General Election, which will be held on Tuesday, Nov. 2. For that election, Early Voting will begin on Wednesday, Oct. 13.

2. City Announces Labor Day Weekend Schedule

City of Knoxville offices will be closed Monday, Sept. 6, for the Labor Day holiday. This includes the Office of Neighborhood Empowerment.

Waste Connections will run residential garbage and recycling routes on Monday, Sept. 6; city residential pickup days will not change for the holiday. (As a general reminder, Thanksgiving and Christmas are the only days of the year when residential curbside trash and recycling are not picked up as scheduled.)

Downtown trash and recycling will also run on its regular schedule throughout the Labor Day weekend.

The City's five recycling centers will be open, but the Goodwill attendant will not be available to receive household goods donations on Monday, Sept. 6.

The City's Solid Waste Facility located at 1033 Elm Street will be closed on Saturday, September 4 and Monday, September 6. Due to the holiday, Free for City Residents Saturday at the Solid Waste Facility will be held on the second Saturday of the month, Saturday, Sept, 11.

4. Mayor Kincannon Names Community Safety Director

Tuesday morning, Mayor Indya Kicannon announced the appointment of LaKenya Middlebrook as the City's new Community Safety Director.

This new cabinet-level position will oversee and coordinate all aspects of community safety, increasing collaboration between the Mayor, her leadership team, KPD, KFD and other community partners who are on the ground to address public safety issues in Knoxville.

"LaKenya Middlebrook is an effective and passionate leader who works tirelessly for justice in all situations," Mayor Kincannon said. "She has established relationships with key partners that will help us build out sustainable violence interruption programs and other solutions that will work best in our city."

Middlebrook will transition from her current role as the Executive Director of the City's Police Advisory & Review Committee (PARC) to Director of Community Safety in early September.

5. City Hosts COVID-19 Vaccine Clinics

Have you been waiting for the COVID-19 vaccine to become fully approved by the FDA? That time has come, and the City of Knoxville is hosting three vaccine clinics to increase opportunities for City staff and members of the public to get the vaccine. The newly FDA-approved Pfizer vaccine will be administered by Knox County Health Department staff to all eligible persons ages 12 and older at the following times and locations:

- Monday, Sept. 13 (1st Shot) and Monday, Oct. 4 (2nd Shot), at the City County Building's Small Assembly Room, 400 Main Street (10 a.m. to 3 p.m.);
- Tuesday, Sept. 14 (1st Shot) and Tuesday, Oct. 5 (2nd Shot), at the Public Works Building's Community Room, 3131 Morris Ave. (10 a.m. to 3 p.m.);
- Friday, Sept. 17 (1st Shot) and Tuesday, Oct. 12 (2nd Shot), at the Civic Auditorium Lobby, 500 Howard Baker Jr. Ave. (10 a.m. to 3 p.m.).

Appointments are not necessary. Check with your doctor if you have any questions about this vaccine.

6. National Night Out Scheduled for Oct. 12

National Night Out (NNO) is on! Due to the high level of the COVID-19 virus in our community, City officials encourage neighborhood groups that want to participate to host outdoor events, but if that is not possible, to host indoor events with attendees wearing masks.

If your neighborhood is not comfortable doing an event, there are other ways to show your support:

- Decorate in Blue
- Leave Your Lights On
- Send Thank You cards

Decorate in Blue – Decorate your mailboxes, yards, houses, etc., with signs supporting the police, sidewalk chalk, or any other creative ideas. Be sure to include the major streets your neighborhood would like to highlight in your registration for Police Officers, Fire Fighters, First Responders, and City Council, to drive through and see your support.

Leave Your Lights On – This traditional way to show support for the police is a classic NNO option. If your neighborhood chooses to leave the lights on, officers will do their best to drive through and see your demonstration of support.

Send Thank You Cards – Simply sending a thank you card to KPD, a specific officer, an officer liaison, and/or the Chief, is another way to show support. Send mail to: KPD, National Night Out, 400 Main St., Knoxville, TN 37901.

7. City Requests Public Input on CAPER

The City of Knoxville is looking for public input on the program year 2020-2021 draft of the Consolidated Annual Performance and Evaluation Report (CAPER).

It will be available for public review and comment for 15 days beginning on **Monday**, **Sept. 13, and ending Monday Sept. 27**.

The report describes how the City of Knoxville spent Community Development Block Grant (CDBG), Emergency Solutions Grant (ESG), and HOME Investment Partnerships Act (HOME) funds received from the U.S. Department of Housing and Urban Development (HUD) during the program year that ended June 30, 2021. The report will also describe how the City used supplemental funding from HUD through the CARES Act, including CDBG-CV and ESG-CV funds, which were given to prevent, prepare for, and respond to COVID-19.

The draft report will be available for review in the City's Housing and Neighborhood Development Office, Fifth Floor, City-County Building, 400 Main Street and on the City's website at <u>www.knoxvilletn.gov/development</u> under "Reports and Plans." The draft report may also be mailed to interested parties upon request by calling Cicely Henderson at 215-2180. The final report will be submitted to HUD by Sept. 30, 2021.
