## **2. Board of Zoning Appeals Meets Next Week**

The Board of Zoning Appeals (BZA) meets next week on Tuesday, Oct. 19, at 4 p.m. in the Small Assembly Room of the City County Building.

BZA hears certain appeals of denials of building permits by the City's Plans Review and Inspections Department. An applicant can request a variance from the Zoning Code requirements or can appeal an administrative official's interpretation of the Zoning Code.

## **3. Historic Zoning Commission Meets Next Week**

The Historic Zoning Commission will meet on Thursday, Oct. 21, at 8:30 a.m. in the Small Assembly Room of the City County Building.

The Historic Zoning Commission works with developers and property owners to encourage the preservation of historic sites and areas and to integrate historic facilities into other plans. The commission reviews applications for building permits for construction or demolition within designated historic zones. The commission also acts

as an advocate for changes in various local, state, and federal laws that affect historic sites.
