4. Early Voting Begins July 15

Early Voting for the Federal and State Primary and the Knox County General elections begins on Friday, July 15 and goes until Saturday, July 30. During early voting, you may go to any polling site. See all <u>polling locations</u>.

Thursday, Aug. 4 is Election Day for both the Federal and State Primary as well as for the Knox County General.

The final day to request an absentee ballot is Thursday, July 28. To request an absentee ballot, go to the Knox County Election website, fill out the Absentee Ballot application, and email the completed form to absenteeballot@knoxcounty.org. You must meet certain qualifications to vote absentee.

If you are unsure whether you are registered to vote, check your status at the <u>Tennessee Secretary of State website</u>. This website will also provide your polling location, district information, and Election Day information. To see who is on the ballot, go to the <u>Knox County Election website</u> and click on the sample ballots.

5. Let's Compete with Chattanooga

There is a healthy competition going on between Chattanooga and Knoxville to see which community can get the most residential yards certified as Tennessee Smart Yards. The NoogaKnox Challenge encourages residents to make their yards more stormwater friendly through native plantings, use of swales, and other techniques.

We are all connected by water—streams flow into rivers and into the ocean. And it begins as rain falling into our yards and into storm drains. What you do in your yard can end up downstream.

If you want to start your yard improvements today, go directly to <u>Tennessee Smart Yards</u> to download the workbook and begin the certification process. Knox County residents who gets certified between now and Sept. 21, will count toward the NoogaKnox Challenge.

6. Animal Care and Control in the City

Listed below are several resources for having/finding animals in Knoxville including adoptable animals, animal control, and dead animal pickup.

If you live within the City limits, all of your pets are required to possess a City tag. Your pet must have an up to date Rabies Vaccine in order to purchase a tag. This tag must be purchased annually and worn by your pet, just like the Rabies tag. Young-Williams Animal Center and most veterinarians in the City offer the sale of City tags. For more City pet ordinances, please visit the <u>City of Knoxville's website</u>.

Do you need to contact Animal Control? The City Animal Control office is open Monday-Friday 7 a.m.-10 p.m. as well as Saturday, Sunday and holidays 10 a.m.-6 p.m. For stray animal pickup in the city, call 865-215-7457. To leave a voice message only, call 865-215-8639. For more information, contact Keith Hogue at 865-215-8640 or khogue@knoxvilletn.gov.

The Tennessee Wildlife Resources Agency (TWRA) has jurisdiction over wildlife, including bats, skunks, raccoons, foxes, and coyotes. City and County Animal Control Officers can respond to calls about wildlife that are sick/injured, and pose a direct safety risk to the public. TWRA's number is 1-800-332-0900.

To request pickup for a dead animal in the city, please call 3-1-1 (865-215-4311) or make the request using the My Knoxville app. The animal must be within 5 feet of the edge of the street. The animal is placed in a biohazard bag and taken for burial to the Chestnut Ridge Landfill off Raccoon Valley Road. To request dead animal pickup online, please click here.

7. Take It Easy During High Temps

Hot weather can trigger a variety of medical emergencies. Even healthy people should take it easy during extremely high temperatures, and those with respiratory and other health problems must be especially careful.

Heat-related injuries fall into three major categories: heat cramps, heat exhaustion, and heat stroke.

Heat cramps are muscular pains and spasms that occur when the body loses electrolytes during profuse sweating or when inadequate electrolytes are taken into the body. They usually begin in the arms, legs or abdomen, and often precede heat exhaustion. The best thing for heat cramps is to rest in the shade, get near a fan, spray the person with water, massage the cramp, and drink something with electrolytes in it.

Heat exhaustion is a medical emergency. When a person is suffering from heat exhaustion, they will perspire profusely and most likely will be pale. It is best to get to a cool place, apply cool compresses, elevate the feet, and drink something with electrolytes in it.

Heat stroke is the worst heat-related injury. The brain has lost its ability to regulate body temperature. The person will be hot, reddish and warm to the touch. Their temperature will be markedly high and there will be no perspiration. This is a medical emergency; call 9-1-1. The emergency care of heatstroke is to cool the body as quickly as possible. One of the best methods for cooling the body during a heat emergency is to wrap the patient in cool, wet sheets.

The best ways to prevent a heat-related emergency are:

- Drink before you're thirsty and drink often.
- Eat a healthy diet.
- Wear a hat or cap, keep the neck covered and wear loose fitting clothing.
- If you can, work during the cooler hours of the day or evening.
