The City of Knoxville has extended the deadline to accept applications for the Neighborhood Advisory Council to Friday, Sept. 2, 4:30 p.m.

The Neighborhood Safety and Awareness series is a collaboration between the City of Knoxville Office of Neighborhood Empowerment (ONE), Police Advisory and Review Committee (PARC), the Community Safety Department, Knoxville Police Department (KPD), and the East Tennessee Valley Crime Stoppers initiative.

Residents of the 1st City Council District – including Fort Sanders and South Knoxville neighborhoods – are invited to learn about the specific types of crimes happening in their neighborhoods and best practices for community safety, crime prevention, and safety awareness. The Police Advisory Review Committee will have their second quarterly meeting of 2022 on Thursday, Aug. 25, at 6 p.m., at the City County Building, Small Assembly Room, 400 Main Street.

During this meeting, the PARC members will be reviewing files that came through their office from April-June of 2022.

6. What is Public Officer Hearing? When Do They Meet?

After the Neighborhood Codes Enforcement office issues complaints to property owners regarding structures that are alleged to be unfit or dangerous, the Public Officer holds hearings and issues orders to property owners to make repairs or to demolish unfit structures.

If the property owner does not comply with the order, the City may repair or demolish the structure and bill the owner for the service. A lien can also be placed against the property to recover expenses for repair or demolition. The Public Officer may also order an owner to alter, improve, secure, board, or vacate and close a structure. The property owner may appeal the Public Officer's order to the Better Building Board within 10 days of receipt of the order.

The Public Officer Hearing is held on the last Friday of the month, the day after the Better Building Board. Their next meeting is this Friday, Aug. 26, at 9:30 a.m. in the Small Assembly Room, City County Building, 400 Main St.

The properties on the <u>agenda</u> are: 6105 Chapman Hwy - Commercial; 6107 / 6109 / 6111 / 6113 / 6119 Chapman Hwy – Commercial; 1735 Maryland Ave.; 2525 Sutherland Ave.; 1734 Tennessee Ave., including accessory structure; and 2743 Wilson Ave. Confirmation of emergency repair/demolition order.

If any of these properties are in your neighborhood, you may want to attend the meeting in order to speak to the condition of the property.

7. What is Better Building Board? When Do They Meet?

The Better Building Board hears appeals of the Public Officer's orders.

The Better Building Board holds hearings and may affirm or alter the Public Officer's order. If the property owner does not comply with the Better Building Board's order, the City may repair or demolish, alter, improve, secure, board, or vacate and close the structure and bill the owner for the service. A lien can also be placed against the property to recover expenses for repair or demolition. The property owner may appeal the Better Building Board's order to the Knox County Chancery Court. The Better Building Board may also hear cases regarding the City's acquisition of property or the enforcement of the Demolition by Neglect ordinance.

The BBB meets fourth Thursday of the month. Their next meeting is this Thursday, Aug. 25, at 3:30 p.m. at the Small Assembly Room, City County Building, 400 Main St.

The one property on the <u>agenda</u> for this month is 205 Spruce St.

If a property on the list is in your neighborhood, you may want to attend to speak to the Board about the condition of the property.

Job seekers looking for steady, satisfying outdoor work that helps keep Knoxville clean and operating efficiently are invited to the Public Service Job Fair on Thursday, Sept. 15, from 8 a.m.- 12 p.m. at the Public Works Service Center, 3131 Morris Ave.

More than 30 open positions are available, including the entry-level Public Service Worker, whose duties may consist of:

- Picking up brush and litter from streets, parks or other areas within the City.
- Assisting in laying brick or block for catch basins and retaining walls.
- Pouring and finishing concrete for sidewalks, curbs and gutters.
- Weed control, cutting, trimming and pruning trees, flowers and shrubs and maintaining undergrowth.
