1. Deadline to Nominate Your Good Neighbor is Fast Approaching

The deadline to nominate your good neighbor(s) is Friday! If you have a neighbor who goes above and beyond to help individuals, your neighborhood or the community at large, please consider nominating this person for the Diana Conn Good Neighbor of the Year Award.

This award is presented annually to Knoxville resident who — in a spirit of cooperation and with commitment to inclusive community — has devoted time and talent in service to his or her neighbors and neighborhood. The award is meant to honor someone who makes a positive contribution at the neighborhood level without seeking recognition for their service.

The deadline for nominations is **4:30 p.m. this Friday, Dec. 2**. Nominees must live within Knoxville city limits. Previous nominees may be nominated again. More than one nomination may be submitted for a single nominee. The winner and all nominees will be honored at an invitation-only dinner in early March 2023. 3. City Council to Hear Neighborhood Small Grants Program

At tonight's City Council meeting, members will hear the four applications for Neighborhood Small Grants Program for 2023.

Neighborhoods requesting funding are:

Fairmont Emoriland Neighborhood Association - \$2,500 Historic Gibbs Drive Neighborhood Association - \$3,000 Historic Sutherland Heights Neighborhood Association - \$2,000 Mechanicsville Community Association - \$3,000

The total allocation for this cycle is \$10,500

The process for requesting Neighborhood Small Grants Program funds begins in the spring with a mandatory grant workshop. Applications are due in the summer. There are site visits and a committee review in the fall, and then funding is issued – upon Council approval – in January.

5. Trees Knoxville Presents Urban Forest Future

Trees Knoxville – in partnership with City of Knoxville, Knoxville Utilities Board, Tennessee Division of Forestry, and Keep Knoxville Beautiful – will launch the Urban Forest Master Plan project on Wednesday, Dec. 14, 5:30 to 7 p.m. the Civic Coliseum, 500 Howard Baker Jr. Ave. Free parking will be available at the Coliseum parking garage.

Trees play a vital role in our community by providing many environmental, social and economic benefits. Now is the time for you to give your input on the upcoming Urban Forest Master Plan, a 20- to 30-year roadmap on what our community needs to do to maintain and increase tree cover across Knoxville.

Trees Knoxville will introduce this project and its timeline and let residents know how to get involved. There will be a presentation on the current state of Knoxville's urban forest

and the results from the 2020 Urban Tree Canopy Study. Consultant Urban Canopy Works will give a presentation on the Urban Forest Master Plan that was completed in Tallahassee, Florida. The event is open to the public, so bring your friends and family. Trees Knoxville wants to get as much input from the public as possible.
