1. Early Voting Is Going On Now!

Now through Thursday, April 28, the following early voting locations will be open for the 2022 Knox County Primary Election:

3. Register Now for Neighborhood Small Grants Workshop

Neighborhood groups wishing to apply for a Neighborhood Small Grant <u>must</u> send a representative to ONE of three mandatory pre-application workshops being held **Saturday, Apr. 23; Tuesday, Apr. 26; OR Wednesday, May 4**.

Even if your group is doubtful you will apply, send someone to one of the workshops anyway. It could help you learn how to apply in the future or it could ensure that you have met this requirement to preserve your right to apply in this 2023 round.

4. Neighborhood Safety Series Workshop Scheduled for West Knoxville

West Knoxville neighbors are invited to the next Neighbor Safety and Awareness workshop on Thursday, May 19, 6-8 p.m. in the gym at the Deane Hill Recreation Center, 7400 Deane Hill Dr. This meeting will focus on crime data and safety in West Knoxville neighborhoods located in City Council Districts 2 and 3.

This is the second in a series of four neighborhood safety workshops presented collaboratively by the Office of Neighborhood Empowerment (ONE), Police Advisory and Review Committee (PARC), the Community Safety Department, and Knoxville Police Department. A representative from East Tennessee Valley Crime Stoppers will also attend to explain how their program works.

Neighbors will learn more about the crimes being reported in their neighborhoods and the City departments and agencies working for and with neighbors on public safety. Presenters will share best practices for community safety, crime prevention and safety awareness. Future meetings will be held quarterly in North and South Knoxville neighborhoods. The meeting for East Knoxville was held on Feb. 24.

5. Brush Pick Up Has Resumed

Our Public Service Department has a very robust system in place for brush and leaf collection throughout Knoxville's neighborhoods. From November through February, they provide leaf collection. From March through October, brush is collected every two weeks in your neighborhood.

In order to find out which week is yours, go to the <u>City's website</u>, enter your street name and it will tell you the date of your next brush pick up. If you put out your brush by Sunday afternoon prior to your week, it will be picked up sometime that next week.

If for some reason your brush does NOT get picked up, you can call 311 or put in a request to have the brush picked up by going to the <u>City's website</u>, scroll to the bottom of the page, and enter in the request under Trash / Recycling Pickup Missed.

6. Health Department Hosts Heart Healthy and Diabetes Prevention Workshops

The key to a healthy life is a healthy heart, so learn more about yours in the Knox County Health Department's Healthy Heart series, starting soon.

This series will be presented in three parts: heart-healthy eating, physical activity, and strategies for a healthier lifestyle.

This series is open to absolutely anyone and will take place on three consecutive Thursdays via Zoom. The dates will be May 12, 19, and 26, from 6-7 p.m. This series usually takes place around four times a year, so if you are not able to register for this round, not to worry! A new series will begin in August.

Another exciting program from the Health Department is the Diabetes Prevention Program, which is a 12-month lifestyle change program. New cohorts launch monthly, but space is limited, so feel free to take this eligibility survey.

8. Sports Authority to Meet April 26

The Knox Sports Authority board members as well as City and County staff will meet at 8:30 a.m. on Tuesday, April 26, at the City's Public Works Service Center, 3131 Morris Ave., to discuss the multi-use stadium development in downtown Knoxville.

The total economic impact of a publicly owned multi-use stadium and surrounding private development is projected to be nearly \$480 million over 30 years. More than 400 full-time jobs are expected to be created.

The Sports Authority will be financing, overseeing construction of, and managing the stadium, to be built on property just east of the Old City. The stadium is expected to host hundreds of events each year – professional baseball games, but it also is designed to accommodate everything from soccer matches to concerts and festivals to other public events.

The City and County's anticipated payment toward the stadium debt would be about \$240,000 for each government annually for the first 10 years. At that point, according to an independent economic impact analysis, the project has the potential to pay for itself.

9. Do You Have Pesky Vines Growing on Your Tree?

Meg Stanton, a plant pathologist at the University of Tennessee, is here to tell you how to safely remove unwanted vines growing up your tree.

First and foremost, safety should be your top priority. Be mindful of poison ivy!

Carefully use sharp pruning shears to clip the vines all the way around the tree without cutting into the bark. Do not attempt to pull the vines down or away from the bark. Pulling the vines can damage the bark on the tree or even break off branches. Instead, let the vines die in place and fall off on their own.

If you can, remove the vine's root system by pulling the roots out of the ground and discarding them.

It's normal for your tree to look a bit different for a while after you've removed the vines. A change like this can stress a tree as it adjusts. You can help to subside this by throwing mulch around the base of the tree, but be careful not to let the mulch touch the trunk, as this can promote disease. Watering during dry or drought periods is also helpful.
