1. Best Wishes to Evan on Graduating

Evan's internship with the Office of Neighborhood Empowerment (ONE) has come to a bittersweet end, and he will graduate with his bachelors in Social Work later this month.

Evan was named one of only 11 Torchbearers at the University of Tennessee, the highest honor the university gives to undergraduates. We are very proud of him and his many accomplishments on and off campus

Not only has Evan excelled at school, he has also been a tremendous asset to our office, helping with administrative tasks such as answering phones and assembling this weekly newsletter, the *Neighborly Notice*. He successfully ran the booth room at the 2022 Neighborhood Conference. He spoke on stage and helped greet everyone at the first annual Neighborhood Awards Dinner back in March. Evan attended multiple neighborhood meetings and events, assisting neighbors whenever he was able. He also helped evaluate many of our office's programs, and he created a sample grant application to help those interested in applying for the Neighborhood Small Grants Program.

Evan intends to pursue a career in law once he graduates, and he is waiting to hear back from several schools.

2. FENA Hosted Arlington Garden Dedication Event

The **Fairmont Emoriland Neighborhood Association (FENA)** hosted an event this past Sunday to celebrate the great work done in what is now known as Arlington Garden.

In 2000, FENA was formed to channel neighborhood input into First Creek flood control plans being proposed by the City for the portion of the creek north of Emoriland Boulevard to Broadway at Chickamauga Avenue. A final improvement to the plan was the acquisition and demolition of the Pizza Hut located on the corner of Emoriland and Broadway.

The FENA board and others decided that a pollinator garden would be a wonderful addition to the neighborhood and would provide a gathering space for neighbors in the lot where the Pizza Hut once stood. The neighborhood began participating in the Neighborhood Small Grants Program (NSGP) in 2019 and has worked with the City's Parks and Recreation department to bring their vision to life. Many volunteers have worked hundreds of hours to help develop and maintain the garden, and the neighborhood has continued to participate in the NSGP to help fund new ideas and improvements.

The Office of Neighborhood Empowerment (ONE) was happy to attend and be a part of such a special event.

8. Trees Knoxville Hosts Open House May 11

Urban Canopy Works and Trees Knoxville, in partnership with the City of Knoxville, are helping the City evaluate its tree cover and get input from residents, business owners, property owners and major landholders about what the community wants to do moving forward with regard to the tree canopy.

Plan to attend the Urban Forest Master Plan Open House this Thursday, May 11, 4-7 p.m. at the Cansler YMCA, 616 Jessamine St. Presentations will be given at 5 p.m. and again at 6 p.m. Registration is not required – just show up.

9. South Knoxville Group Hosts Commercial Zoning Meeting

The **South Knoxville Neighborhood & Business Coalition** (SKNBC) is hosting a community meeting to help residents learn more about a proposed change to General Commercial Zoning (C-G-2 & C-G-3) specifications.

The meeting will be held Thursday, May 25, from 5-6:30 p.m. on the patio at 71 South, South Knoxville's newest restaurant, located at Baker Creek Bottoms.

This zoning change, if approved, could affect Chapman Highway south from Young High Pike.

The purpose of the C-G General Commercial Zoning District is "to provide for a heterogeneous mix of retail, personal services, office and residential uses…" and is intended to promote mixed-use development in a pedestrian-oriented development.

The change is being recommended to remove the build-to-percentages and build-to-zones for this area. The current standards require new buildings to be built closer to the road, like the new Fast Pace Health location across from Checkers. Having buildings closer to the road makes the area more walkable.

10. Knoxville SOUP Hosts Fundraising Dinner

Knoxville SOUP will host its next micro-fundraising community dinner on Wednesday, May 17, at Dara's Garden, 2637 Maryville Pike. Rothchild's Catering will provide dinner.

Doors open at 5:30 p.m., and presentations start at 6 p.m.

Here is how Knoxville SOUP works: attendees give a suggested donation of \$5 or more at the door and receive soup, salad, and a vote. Multiple groups present their projects for which they request funding. Attendees cast their votes and all the money collected at the door goes to the winner. Then folks can eat, mingle, and collaborate.

It is an opportunity for the community to gather, share, and connect. It is also an opportunity to support local projects that benefit the community as a whole.

11. CORRECTION: Open Streets 2023 Slated for June 4

Previously, we published that Open Streets 2023 was slated to occur on June 6. However, the correct date is Sunday, June 4, 2-4 p.m. in the Downtown North Knoxville area. We regret the error.

The route will be the first-ever loop and will include sections of Depot St., Gay St., Central St., Emory Pl., 3rd Ave., 4th Ave, and Lamar St. Check out the map route on BWK's website.

Open Streets, hosted by Bike Walk Knoxville, brings together community groups and local businesses, giving people of all ages and abilities the opportunity to walk, ride bikes, hula hoop, and much more in a safe, fun setting.

All are welcomed to join in the activities.

13. What is the Right Tree, Right Spot?

If you plan to plant a tree in your yard, you can help reduce power outages for you and your neighbors by following these simple steps to smart landscaping:

- Choose the right tree.
 - Before making your selection, be sure to determine how tall and wide the tree will be at maturity and how deep the root system will be.
 - Select a native plant, which will require less water, fertilizer, and pesticides to maintain. A list of native plants and trees can be found here.
- Choose the right spot.
 - o Remember to look up to make sure that you are clear of any power lines.
 - Pick your spot based on the mature size of your tree to ensure there will be enough clearance as it grows.
 - If you are not sure, you can always ask a tree specialist.

In the end, this will help you, your neighbors, and our Knoxville Utility Board (KUB).
