- 2) Process updates
 - a) New timeline / partnership with regional TPO (Brian Blackmon)
 - i. previous meeting, discussed how we were focused on federal Safe Streets for All (SS4A) funding opportunity. Afterwards, new opportunity to partner with TPO arose a regional roadway safety plan. As a result, we're going to change course and community engagement timeline will be pushed back (winter/spring 2023). New process will still result in creation of City-specific VZ Action Plan but this allows for a regional collaborative effort (transportation issues aren't confined to city boundaries, so regional collaboration makes more sense).
 - 1. Bryan Hill: City was originally going to lead planning effort. Why change?
 - 2. Brian Blackmon: SS4A program is basically VZ. We were originally going to apply for SS4A Planning Grant, but Implementation Grant allows us to leverage more stakeholders, bigger funding, more reasonable timeline.
 - b) Regional Roadway Safety Plan (Ellen Zavisca)
 - i. Knoxville-Knox County Planning / Knoxville Regional TPO: works with City, Knox County, and surrounding counties for comprehensive regional transportation planning.
 - ii. Opportunity to fund planning process over next year to set up Knoxville and other local governments to apply for SS4A Implementation grant funds in 2023.
 - iii. Safe Systems: USDOT supporting. Focus on collaborative approach to traffic safety, that all users are vulnerable to injury/death, and that we're all responsible for eliminating human loss.

- iv. Plan will align with USDOT priorities (for federal funding opportunities) and low-cost / high-impact projects or programs (for local funding)
- v. Goal: proactive solutions that prevent crashes
- vi. Will bring together existing data as well as developing predictive model to help identify locations/conditions where crashes are most likely
- vii. Elements of RRSP:
 - 1. Engage with local governments including selecting consultant but TPO staff guiding
 - 2. Local gov't funding + pledge from TDOT
 - 3. Public engagement inc. City effort
 - 4. Scope of Work includes:
 - a. crash data analysis + creation of predictive model
 - b. Capacity building
 - c. Public engagement
 - d. Prioritized projects/strategies
- viii. Recap of existing data see TPO website
- c) Updated timeline (Brian Blackmon)
 - i. This partnership allows for more stakeholder participation, better collaboration, etc and accelerates access to larger funds
 - ii. Self-certified SS4A plan by summer 2023
 - iii. Apply for SS4A Implementation grant in September 2023
