BUSINESS BASICS

LEGAL BUSINESS STRUCTURE

For legal and financial purposes, you must have a formal structure for your business: Sole Proprietorship, Partnership, C Corporation, S Corporation (also called Subchapter S Corporation), or Limited Liability Company or Limited Liability Partnership. Choosing the right legal structure for your business will require that you to contact an attorney, CPA or a business counselor.

SCORE and the Tennessee Small Business Development Center (TSBDC) provide free business counseling services and can help you decide the appropriate legal structure for your business.

One of the first steps you should take as a new business is registering for various taxes your business must pay the state. Typically, most businesses must pay business tax and sales tax. All business types, except sole-proprietors and general partnerships, must also register for the payment of franchise and excise taxes.

CITY OF KNOXVILLE BUSINESS TAX LICENSE/TAX OFFICE

State law requires that all businesses (with exceptions for certain professions, manufacturers, and certain disabled persons) inside the city of Knoxville have both city and county business licenses. Please be advised that the purchase of a City of Knoxville or Knox County business license does not authorize you to violate the zoning requirements or relieve you of permit requirements by the Inspections Bureau. Please read the sections in this guide which include information related to zoning, building, fire and other codes and inspections.

Other permits found in the Business Tax License/Tax Office website are: Add Business Partner Affidavit, Amusement Tax Report, Beer Permit, Garage Sale Permit, Going Out of Business Sale Permit, Hotel Occupancy Privilege Tax Form, Out of State Contractor Forms, Vendor License Permit, Wholesale Alcohol Beverage Dealers Monthly Report and Dog in Patios Permit.

Your business license will need to be renewed annually with the Tennessee Department of Revenue and the date is determined by your business classification. You will need to pay city taxes based on gross income receipts.

ZONING AND OTHER REGULATIONS

METROPOLITAN PLANNING COMMISSION (MPC)

Why should you be concerned with city zoning policies? If you open a commercial business in a residential zone or locate your business in a commercial space not intended for that use, your business could be shut down regardless of how much you have invested on renovations or the fact you signed a lease. The business site should be reviewed with the Metropolitan Planning Commission (MPC) to ensure the business activity proposed is appropriate for the location. The Metropolitan Planning Commission (MPC) was established by Knoxville and Knox County as the agency responsible for comprehensive county-wide planning and administration of zoning and land subdivision regulation.

CITY OF KNOXVILLE ZONING ORDINANCE

The City of Knoxville's zoning ordinance helps protect property values by preventing the location of incompatible uses in close proximity to one another. Zoning regulations also help maintain the character of established neighborhoods and prevent inappropriate activities, such as auto repair businesses in residential areas. The ordinance regulates the location, height, bulk, number of stories, percentage of lot coverage, setbacks, open spaces, population density and the uses of all buildings, structures and land within the city limits.

HISTORIC ZONING COMMISSION (HZC)

Exterior changes to a building within a designated historic district may require approval by the Historic Zoning Commission (HZC), which meets regularly on the third Thursday of each month at 8:30 a.m. in the Small Assembly room on the main level of the City County Building, 400 Main Street. For more information contact Kaye Graybeal, Historic Preservation Planner for the Knoxville-Knox County Metropolitan Planning Commission at 865-215-2500 or visit <http://www.knoxmpc.org/historic>.

Minor changes may be approved by the Historic Preservation Planner and HZC review may be bypassed. More significant changes will be considered and voted on by the HZC in a public hearing format at their regular monthly meeting. Approved changes result in the issuance of a Certificate of Appropriateness which is required before a building permit will be considered for the project.

Each historic district or neighborhood has developed Design Guidelines that apply to buildings in the district. These guidelines are the basis for HZC decisions on proposed changes. It is a good idea to arrange to attend your historic district's neighborhood board meetings and present any proposed changes before appearing in front of the HZC.

DOWNTOWN DESIGN REVIEW BOARD

The Downtown Design Review Board's responsibilities are to review and approve public projects, private development plans, and to advise the Mayor, City Council, the Metropolitan Planning Commission and the Historic Zoning Commission on means, incentives and programs to improve downtown design and foster beautification, safety and related public purposes downtown. The Downtown Design Review Board meets on the third Wednesday of the month at 4:00 p.m. in the Small Assembly Room. CITY OF KNOXVILLE OFFICE OF NEIGHBORHOODS

Businesses looking to set up shop in a particular neighborhood and especially businesses needing a zoning change, use-on-review or other regulatory approvals to be able to develop property in or near a residential neighborhood are encouraged to contact the impacted neighborhood, business and professional organizations to establish communication and a good relationship from the start. <http://www.knoxvilletn.gov/neighborhoods>

DOES YOUR BUSINESS HAVE TO COMPLY WITH THE AMERICANS WITH DISABILITIES ACT (ADA)?

Businesses that provide goods or services to the public are called "public accommodations" in the ADA. The ADA establishes requirements for 12 categories of public accommodations, which include stores, restaurants, bars, service establishments, theaters, hotels, recreational facilities, private museums and schools, doctors' and dentists' offices, shopping malls, and other businesses. Nearly all types of businesses that serve the public are included in the 12 categories, regardless of the size of the business or the age of their buildings. Businesses covered by the ADA are required to modify their business policies and procedures when necessary to serve customers with disabilities and take steps to communicate effectively with customers with disabilities.

CITY OF KNOXVILLE PLANS REVIEW, BUILDING PERMITS & INSPECTIONS

This office is responsible for the review, permitting, licensing and inspection of all construction projects within the City of Knoxville and consists of Plans Review, Building Inspections, Electrical Inspections, Signs and Zoning Inspections, Mechanical/Gas Inspections and Plumbing Inspections.

Building Use Permit:

What is a Building Use Permit?

A Building Use Permit allows a new tenant or property owner to occupy an existing building or tenant space. The Use Permit provides an opportunity for City officials to review the zoning compliance and perform a safety inspection. This process assures legal occupancy by an owner/tenant.

Who needs it?

Any new tenant or owner is required to obtain a Building Use Permit before occupying an existing building.

A Building Use Permit is not required when a Plans Review Application and a Building Permit have been issued for a new building owner or tenant or when the new tenant use is classified as a Group R-2 or Group R-3 Occupancy.

How do I apply for it?

The new tenant or owner must complete a Building Use Permit Application for review, and then schedule a site inspection by the Fire Marshal & the Building Inspections office.

- If the review and site inspection results indicate that there are no code violations, no additional construction or building modifications to be permitted, and no change of use, then the City will issue a Certificate of Completion and Building Use Permit.

- If the review or site inspection results indicate code violations, additional construction or building modifications, or a change of use, then the City will advise the applicant of the necessary requirements for obtaining a Building Permit. Additional building or sign permits may be required.

How Much Does It Cost?

The non-refundable fee for this permit is \$50.00.

How Long Does It Take?

It depends on the results of the application review, the site inspection, and the complexity of your project. If the proposed work will not require additional building or sign permits, then the process will typically take 1 to 2 days.

Expedited Permits:

What is an Expedited Permit?

An expedited permit is available to facilitate less complicated projects. Applicants and design professionals can meet with staff from Plans Review & Inspections and the Fire Marshal's Office to review submitted plans and receive permits on the spot at no additional cost.

Does my project qualify?

The expedited permit process is limited in scope to qualifying structures and occupancy classes, such as:

- Alterations to commercial buildings
 - Business, Mercantile, Storage, Factory and Utility occupancy classes (No restaurant or grocery/food handling uses)
 - Exterior work where no overlay district review is required (Historic Zoning, Downtown Design, etc.)
- Plans must be prepared and stamped by a design professional registered in the State of Tennessee.
- Changes in occupancy do not qualify for expedited reviews.

How do I start?

1. Submit the plans review application for your project including all associated construction drawings by 12:00 pm on any Tuesday. The project will be evaluated to ensure the scope is appropriate for the expedited process and that it complies with all zoning regulations. The application with construction drawings may be submitted in person or emailed to: bldginspections@knoxvilletn.gov .

2. If the project meets the zoning and scope requirements, you will be contacted to schedule a meeting for the following Thursday. Plans Examiners (including the Fire Marshal's Office) will meet with you and your design professional to review your plans. The design professional can modify the plans during the meeting if needed depending on plan review comments. Once approved, the building permit may be issued.

3. If the project does not meet the requirements, you will be notified and the project must follow the standard plans review process. Construction drawings sent via e-mail will not be accepted, requiring electronic submittal (KnoxPlans – <http://www.knoxplans.org>) or submittal of two full sized sets of plans in order to proceed.

What do I need to participate in the Thursday meeting?

- Two (2) full sized sets of stamped plans / construction drawings
- The project design professional

On the day of the meeting?

Meet in room 511 (City County Building) for your expedited permit review. Representatives from Building Inspections and the Fire Marshal's Office will attend to evaluate the project plans, identify any deficiencies or required revisions, and once corrected, the plans can be approved, and permits can be issued the same day.

Pre-Submittal Conferences:

Do you have a complex redevelopment project? Will you encounter zoning issues?

Need a variance? Any TDOT considerations? In a historical district?

Do you have all the permits and waivers you will need?

The City of Knoxville now offers Pre-Submittal Conferences for complex construction or renovation projects where preliminary review information is provided prior to a formal Plans Review---all at no cost to you. City Staff members will review a copy of your plans, offer comments, provide answers to specific questions and offer possible solutions to difficult design challenges. This will help to ensure a successful project when it is submitted later for the official Plans Review

Sign Permits:

A sign permit is required prior to erecting or installing a sign. Electrical work associated with a sign requires a separate electrical permit. All electrical work must be done by a City of Knoxville licensed electrician. The sign inspector must inspect all signs. Ground signs require footing and final inspections. The footing inspection is required prior to pouring concrete and after the hole is dug and steel reinforcement, if required, installed. The final inspection is required after the sign is installed. Wall signs require a final inspection.

On July 21, 2015, City Council adopted a comprehensive sign ordinance with hundreds of components. All new signs must comply with the requirements and standards set in the new sign ordinance, based on your zoning district and the classification of the road where the sign will be located.

FIRE PREVENTION BUREAU – FIRE CODES & INSPECTIONS

What Buildings Are Affected by the Fire Code? The code applies to all commercial and industrial buildings, and all residential buildings. All building plans are reviewed for compliance with the National Fire Protection Association and all construction must be inspected and approved. The mission of the Fire Prevention Bureau (Fire Codes & Inspections) is to make the City of Knoxville a safe place to live, work or visit by providing a reasonable degree of safety to life and property from fire and hazards through enforcement of the City's adopted fire codes and standards. This is accomplished by conducting life safety inspections of existing structures and new building construction.

Under the direction of the Fire Marshal, the Fire Prevention Bureau performs the following services:

- Review and inspect all new construction and remodeling of commercial buildings in conjunction with the City's Building Permits Department
- Review all sprinkler and fire alarm drawings for compliance
- Permit and inspect all flammable and combustible storage tanks (Class I, II, or III) greater than 60 gallons - Including aboveground storage tanks, underground storage tanks, and liquefied petroleum gas tanks
- Permit and monitor blasting operations
- Permit and monitor pyrotechnic displays
- Enforce all state and local codes involving fire safety and prevention
- Inspect and monitor special events for cooking, tents and large public gatherings
- Provide an on-call fire inspector for emergency situations
- Inspect one- and two-family dwellings upon request

KUB WASTEWATER & GREASE TRAP PROGRAMS

Be aware that all food service facilities are required to conduct their operations in such a manner that grease is captured on the user's premises and disposed of properly. Grease cannot be discharged to the sanitary system, since it can cause blockages and result in sanitary sewer overflows or building backups. KUB CROSS CONNECTION CONTROL PROGRAM

The Safe Drinking Water Act and the State of Tennessee regulations governing the safe operation of public water systems require all customers with business-related hazards, fire suppression systems, irrigation systems, or other potentials for risk to install, test, and maintain a backflow prevention device. Water providers must ensure

HEALTH DEPARTMENT FOOD SERVICE LICENSING

The Tennessee Division of General Environmental Health reviews plans required of new food establishments and those planning remodeling to ensure the establishment will meet the minimum construction and installation requirements prior to construction. Prior approval of plans protects applicants from expensive changes after construction and installation.

In short, any facility that is going to be serving food to the general public is required to have: a three compartment sink or commercial grade dish machine, hand sinks every 20' in the food preparation areas, a mop sink on each floor of the establishment, self-closing doors leading to the outside, restrooms for each sex with seating over 16, and smooth and easily cleanable surfaces in the food preparation areas. KNOX COUNTY HEALTH DEPARTMENT-ENVIRONMENTAL DIVISION

Every establishment where food and beverages are prepared and served is inspected at least twice a year or more often as deemed necessary to ensure compliance. Current food permits and the most recent inspection report must be displayed in a prominent location for the public to view. Knox County Health Department's Environmental Health conducts the inspections of all food service establishments, including restaurants and snack bars, to protect the public from the threat of food borne illnesses. TIPS AND SUGGESTIONS FROM INSPECTORS

Selecting the Site for Your Business:

- Before signing a lease or buying a building, check zoning ordinances to make sure the location is zoned for your type of business. If it is not, keep in mind the cost of the rezoning process and the fact that your rezoning request may be denied.

For certain licenses (like beer and liquor licenses), there are requirements that business locations be located a certain distance from schools, hospitals, funeral homes, parks and churches. Call the Metropolitan Planning Commission (MPC) at 865-215-2500 for more information.

- If your business needs a zoning change, use-on-review or other regulatory approvals to be able to develop property in or near a residential neighborhood, you are encouraged to contact the impacted neighborhood, as well as business and professional organizations, to establish a good relationship from the start.
- Leasing or buying space where a business was already in existence does not ensure that space meets current fire and building code. A change of occupancy can trigger the need to bring the space up to current code. For example, do not assume that because a place of business was a previously a restaurant, that it will pass inspection as a new restaurant.

Plans Review, Codes, Inspections:

- Request a pre-plans review meeting with staff from Engineering, Engineering, Plans Reviews and Inspections, Fire Inspections, utility company, etc.), so you can share the vision for your business. This meeting could provide you with information about potential challenges based on the building or

location. Get your questions answered: Will I have to add more parking? Will I need a building permit for my remodel? Will the fire code require more exits, sprinklers or safety equipment? Will I need a grease trap?

- New businesses that will be KUB customers should always contact KUB and ask for information regarding regulatory requirements early on in the startup process. A KUB representative can discuss any special requirements that may apply or perform a site inspection if necessary.
- Allow enough time for the appeals/review processes (Board of Zoning Appeals, Building Board of Adjustments & Appeals, Use on Review, Plat/MPC Approvals, etc.)
- Pay attention to zoning and licensing requirements. They exist to make your business safer. Don't try to cut corners. Invariably, the easy way out ends up costing more time and money.
- Hire a licensed contractor/subcontractor for any general repairs, alterations, demolition or new construction. Contact the City Plans Review & Inspections office at 865-215-2999 to verify subcontractor licenses. Contact State Licensing Board at 1-800-544-7693 to verify General Contractor licenses.
- Maintenance/Inspection of Erosion Protection and Sediment Controls at construction site are a daily activity.
- Don't design/build to the limits of the regulations... have a little wiggle room for variation in construction.
- All building and plumbing modifications typically require a city or county permit and final inspection. Businesses should use a licensed plumber and be sure their plumber obtains the necessary permits and inspections needed for the work. Licensed plumbers, the City of Knoxville Plumbing Inspectors Office and KUB work together to ensure all plumbing requirements are met.
- Food services facilities that are new or are expanding should always contact KUB and request information regarding our Grease Control Program, even if they are moving into a location that already has grease control equipment.
- KUB wastewater customers should always contact KUB before connecting any drains that have the potential to collect stormwater or groundwater to their sewer lateral or the wastewater system. This includes open drains near dumpster pads, roof drains, parking garage drains or sump pumps.
- If your business offers food service, make sure you provide the plans to the Health Department for review. Do not assume the City of Knoxville Plans Review and Inspections Department will forward the plans to the Health Department.
- You cannot call the Health Department and request an inspection of your new establishment, unless you have previously sent your building plans to them to be reviewed.

- If you have a mobile food service unit, don't just "show up" at the Health Department to request an inspection and a license. You need to submit plans for your unit ahead of time.
- After your plans are reviewed by the Health Department, you may receive a request for additional information in writing. Please be sure to comply promptly.
- After your plans are reviewed and approved, any changes to the plans will require you to resubmit the changes for approval. Changes as small as moving a sink or a door by a few inches may cause you to not pass the inspection.
- Do not start construction until a building permit is issued, otherwise you may have costly re-dos.
- Request a pre-construction meeting to clarify anything.
- Call when there is a problem or question with the plans or site conditions. It is more economical and quicker in the long run to resolve issues with line on paper than removing concrete from the ground.
- Pay attention to ADA (American with Disabilities Act) requirements.
- If your food service facility has over 16 seats, the Health Department will require that it has two public restrooms (one for each sex.)
- Do not start operating your business until you have obtained the certificate of occupancy, even if you did not make any changes to the structure or undertake any construction projects.

After Receiving Certificate of Occupancy/Completion:

- Retain copy of Certificate of Occupancy/Completion for your records.

ALCOHOLIC BEVERAGE SALES LICENSING

If alcoholic beverages will be sold or served in your business, certain state law and city code restrictions will apply. For information on either a beer permit or a liquor license, call the Business Tax Office at 865-215-2083. Beer permit applications are available from the Business Tax Office which handles the administrative process. The beer permit applicant must appear before the Beer Board for consideration of their request for a beer permit. Members of City Council sit as the Beer Board, which meets before the second City Council meeting of each month.

For liquor licensing, contact the State Alcoholic Beverage Commission 865-594-6342; you are also required to obtain a City of Knoxville liquor license after State approval.

Procurement Thresholds:

The City solicits sealed bids for purchases of \$25,000 or more. It solicits quotes by email or fax for purchases between the amounts of \$5,000 and \$25,000. Each department is allowed to purchase without a formal competitive process for purchases below \$5,000.

Vendor Notification of Solicitations:

Although the City makes every effort to notify vendors about posted solicitations, it is the vendor's responsibility to check the City's website for such notifications, as well as to check for any addenda resulting from changes to the original solicitation.

Please be advised that the purchase of a City of Knoxville or Knox County business license does not authorize you to violate the zoning requirements or relieve you of permit requirements by the Office of Inspections.
